Introduction

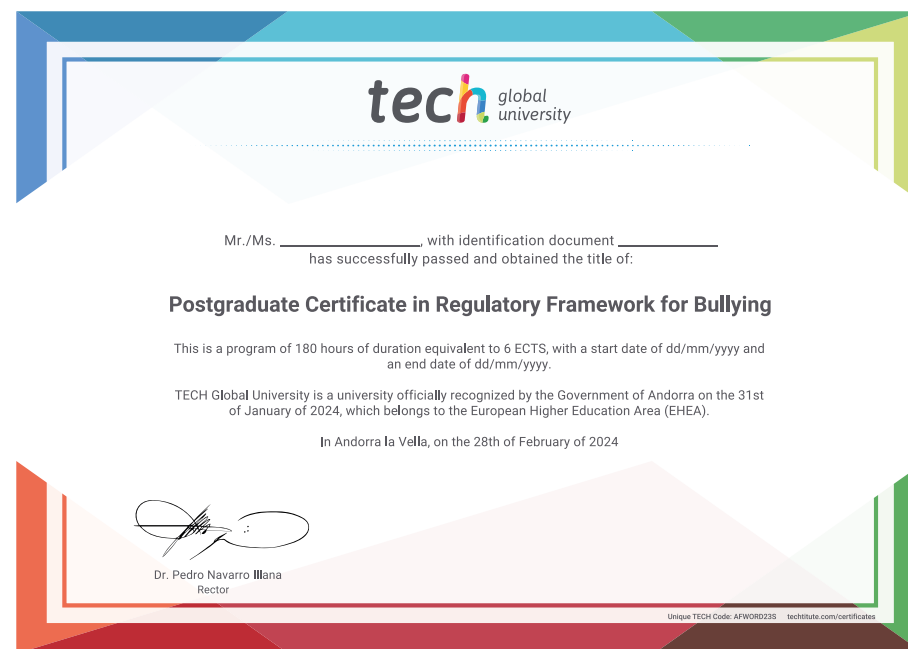
