

Study of Death	Conduct detailed autopsies to determine the cause, manner and time of death.		
	Use postmortem signs such as cadaveric rigidity, lividity, body temperature, and decomposition to estimate time since death.		
	Identify and analyze traumatic injuries to the body to determine their nature and possible relationship to death.		
	Collect and preserve physical evidence from the body such as tissues, body fluids, or foreign objects		
Forensic Sexology	Conduct detailed physical examinations of victims of sexual assault to document injuries, collect biological evidence, and provide immediate medical care.		
	Evaluate physical and genitourinary injuries to individuals, determining their nature.		
	Test for Sexually Transmitted Diseases in victims and suspects, providing appropriate treatment if necessary.		
	Write comprehensive reports that include physical examination findings, laboratory test results, and conclusions about the nature of the attack for later use in legal proceedings.		
Psychiatry and Forensic Medicine	Analyze whether the person is competent to stand trial, understanding legal procedure and being able to participate in their defense.		
	Determine whether defendants had the mental capacity to understand the nature and consequences of their actions at the time of the crime.		
	Assess the risk that an individual may commit violent acts in the future.		
	Establish a subject's capacity to make important decisions, such as consenting to treatment, administering property, or caring for themselves.		
Impact of Injury	Perform detailed assessments to determine the degree of temporary or permanent disability resulting from the injuries.		
	Assess the psychological and emotional impact of traumatic events (such as accident assaults or abuse) and determine the existence of impairments.		
	Prepare expert reports that describe in depth the medical findings, the causal relationship between the incident and the injuries, as well as their implications on the patient's health.		
	Conduct periodic evaluations of individuals to monitor the progress of recovery or the evolution of the patient's health.


### 06 General Conditions

### **Civil Liability Insurance**

This institution's main concern is to guarantee the safety of the trainees and other collaborating agents involved in the internship process at the company. Among the measures dedicated to achieving this is the response to any incident that may occur during the entire teaching-learning process.

To this end, this entity commits to purchasing a civil liability insurance policy to cover any eventuality that may arise during the course of the internship at the center.

This liability policy for interns will have broad coverage and will be taken out prior to the start of the Internship Program period. That way professionals will not have to worry in case of having to face an unexpected situation and will be covered until the end of the internship program at the center.



#### **General Conditions of the Internship Program**

The general terms and conditions of the internship agreement for the program are as follows:

1. TUTOR: During the Internship Program, students will be assigned with two tutors who will accompany them throughout the process, answering any doubts and questions that may arise. On the one hand, there will be a professional tutor belonging to the internship center who will have the purpose of guiding and supporting the student at all times. On the other hand, they will also be assigned with an academic tutor, whose mission will be to coordinate and help the students during the whole process, solving doubts and facilitating everything they may need. In this way, the student will be accompanied and will be able to discuss any doubts that may arise, both clinical and academic.

**2. DURATION:** The internship program will have a duration of three continuous weeks, in 8-hour days, 5 days a week. The days of attendance and the schedule will be the responsibility of the center and the professional will be informed well in advance so that they can make the appropriate arrangements.

**3. ABSENCE**: If the students does not show up on the start date of the Internship Program, they will lose the right to it, without the possibility of reimbursement or change of dates. Absence for more than two days from the internship, without justification or a medical reason, will result in the professional's withdrawal from the internship, therefore, automatic termination of the internship. Any problems that may arise during the course of the internship must be urgently reported to the academic tutor. **4. CERTIFICATION:** Professionals who pass the Internship Program will receive a certificate accrediting their stay at the center.

**5. EMPLOYMENT RELATIONSHIP:** The Internship Program shall not constitute an employment relationship of any kind.

**6. PRIOR EDUCATION** Some centers may require a certificate of prior education for the Internship Program. In these cases, it will be necessary to submit it to the TECH internship department so that the assignment of the chosen center can be confirmed..

**7. DOES NOT INCLUDE:** The Internship Program will not include any element not described in the present conditions. Therefore, it does not include accommodation, transportation to the city where the internship takes place, visas or any other items not listed.

However, students may consult with their academic tutor for any questions or recommendations in this regard. The academic tutor will provide the student with all the necessary information to facilitate the procedures in any case.
