Introduction

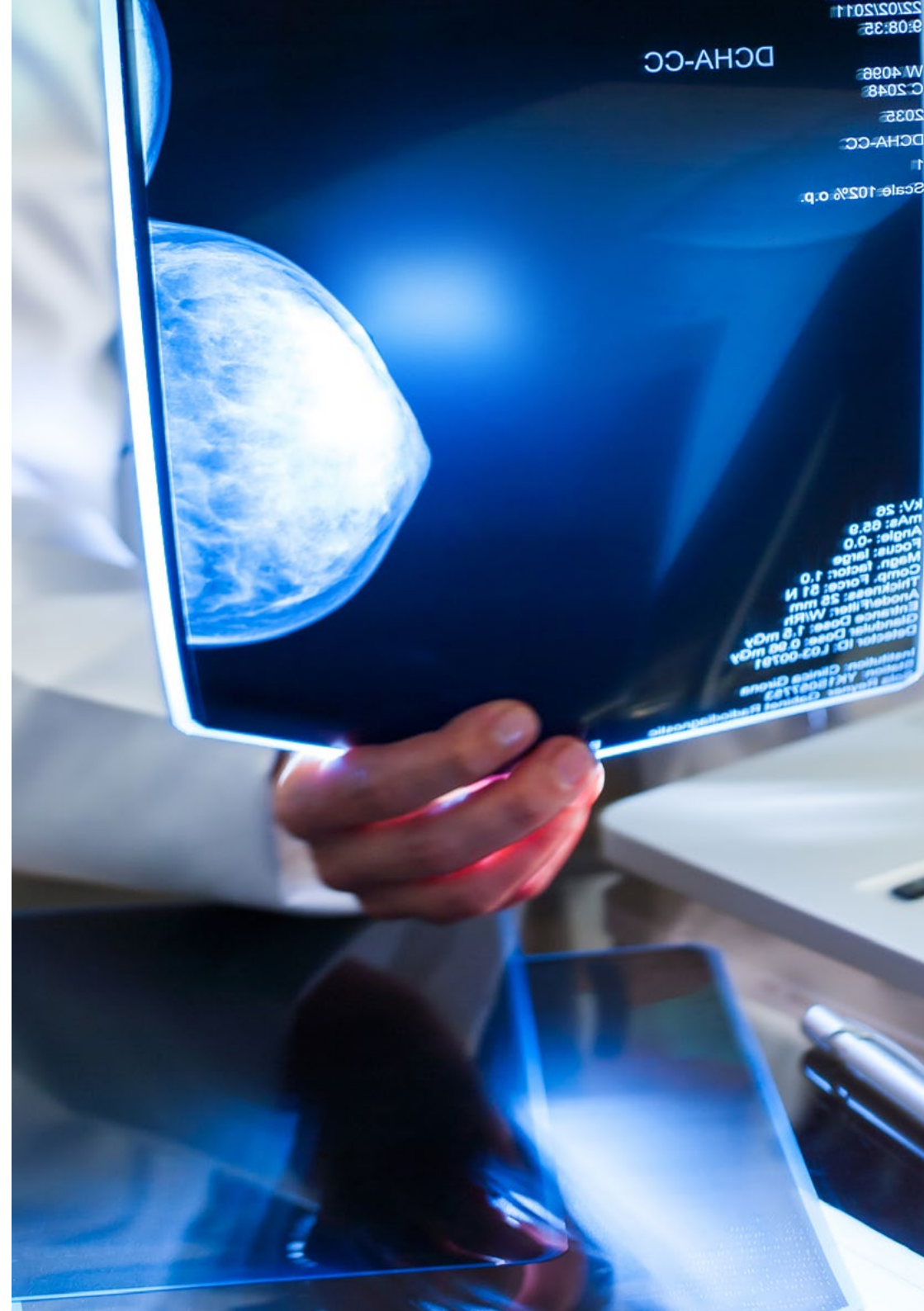
