

Methodology

Did you know that this method was developed in 1912 at Harvard for law students? 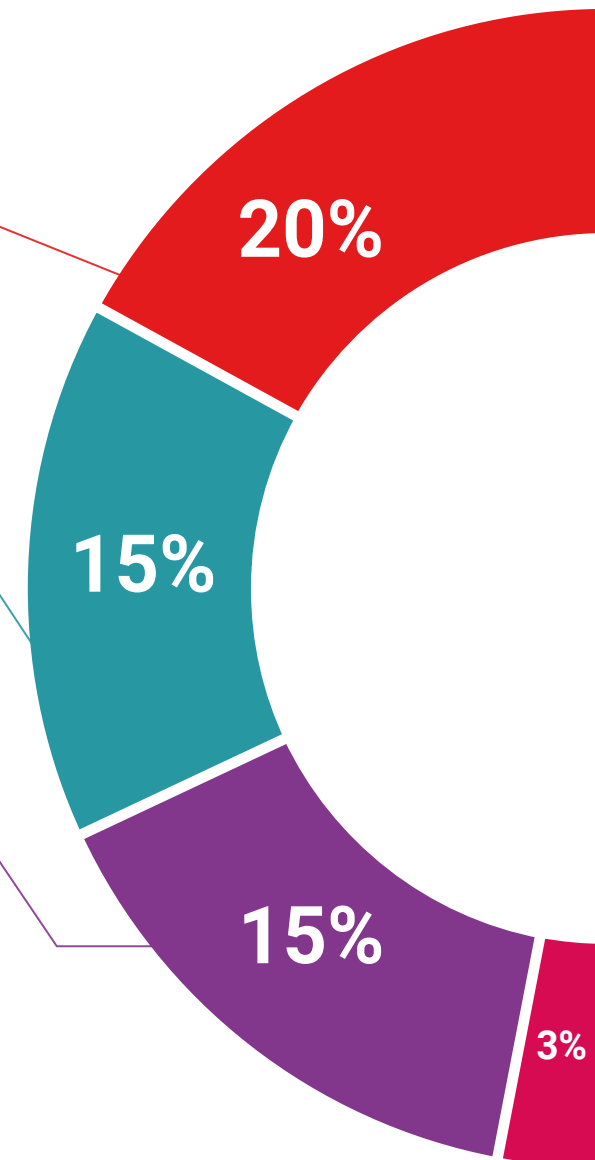
