

The risk of complications is higher in people who have been infected by a blood transfusion and in those patients who also have other viral infections (HIV or hepatitis B) or other health problems affecting the liver, such alcoholism. In this sense, it is important to point out that there is no vaccine that helps to have the defences prepared in case of infection, so treatment with antivirals is recommended, such as for Hepatitis B.


