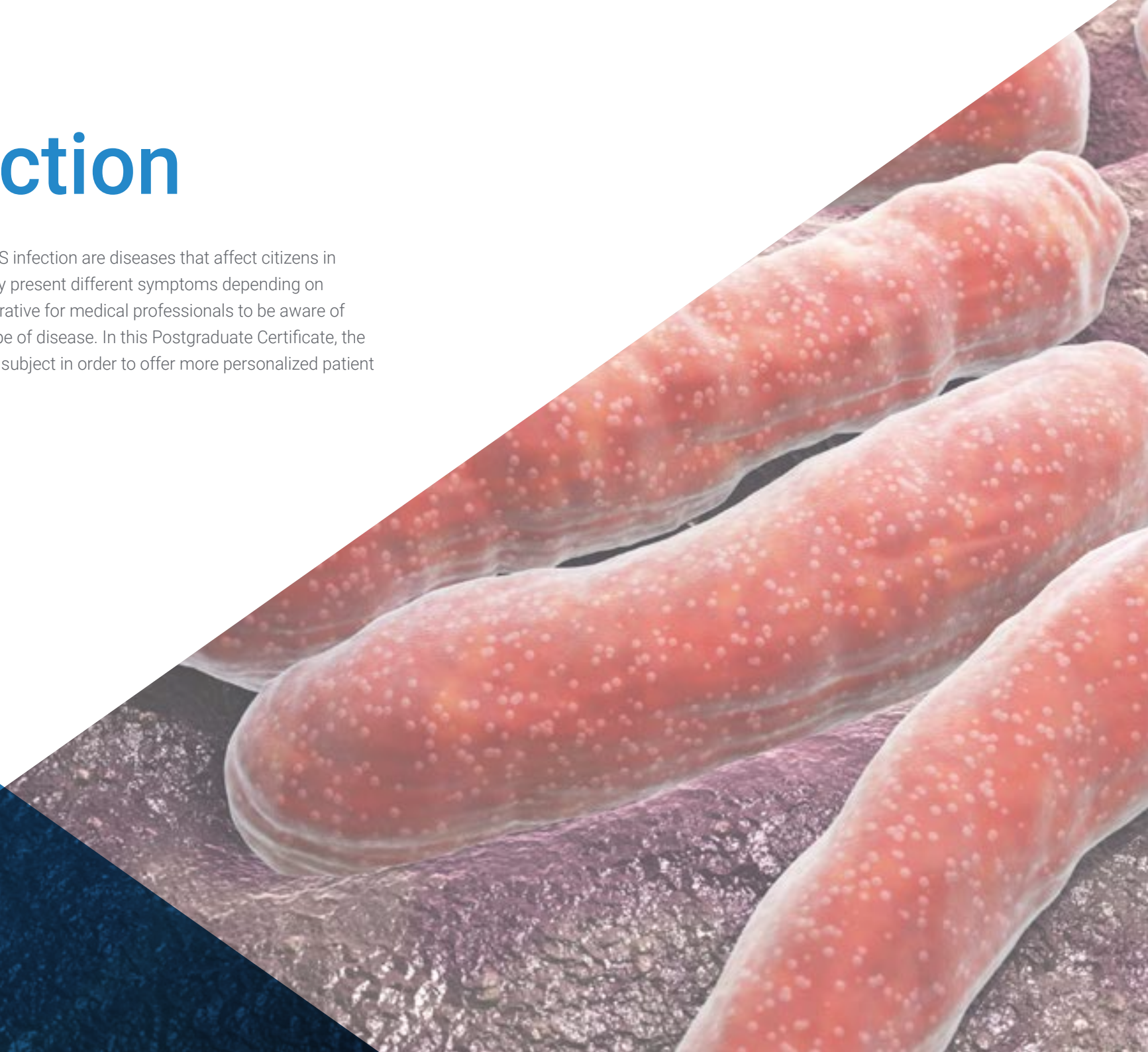

On the other hand, there is VIH/AIDS, the great pandemic, with more than 1.8 million adults dying in 2016 and more than 600,000 children under 15 infected in a single year, and for which current treatment (as well as prevention of vertical transmission) is beyond the reach of many in developing countries, with numerous cases of resistance to the antiretroviral drugs used already detected.

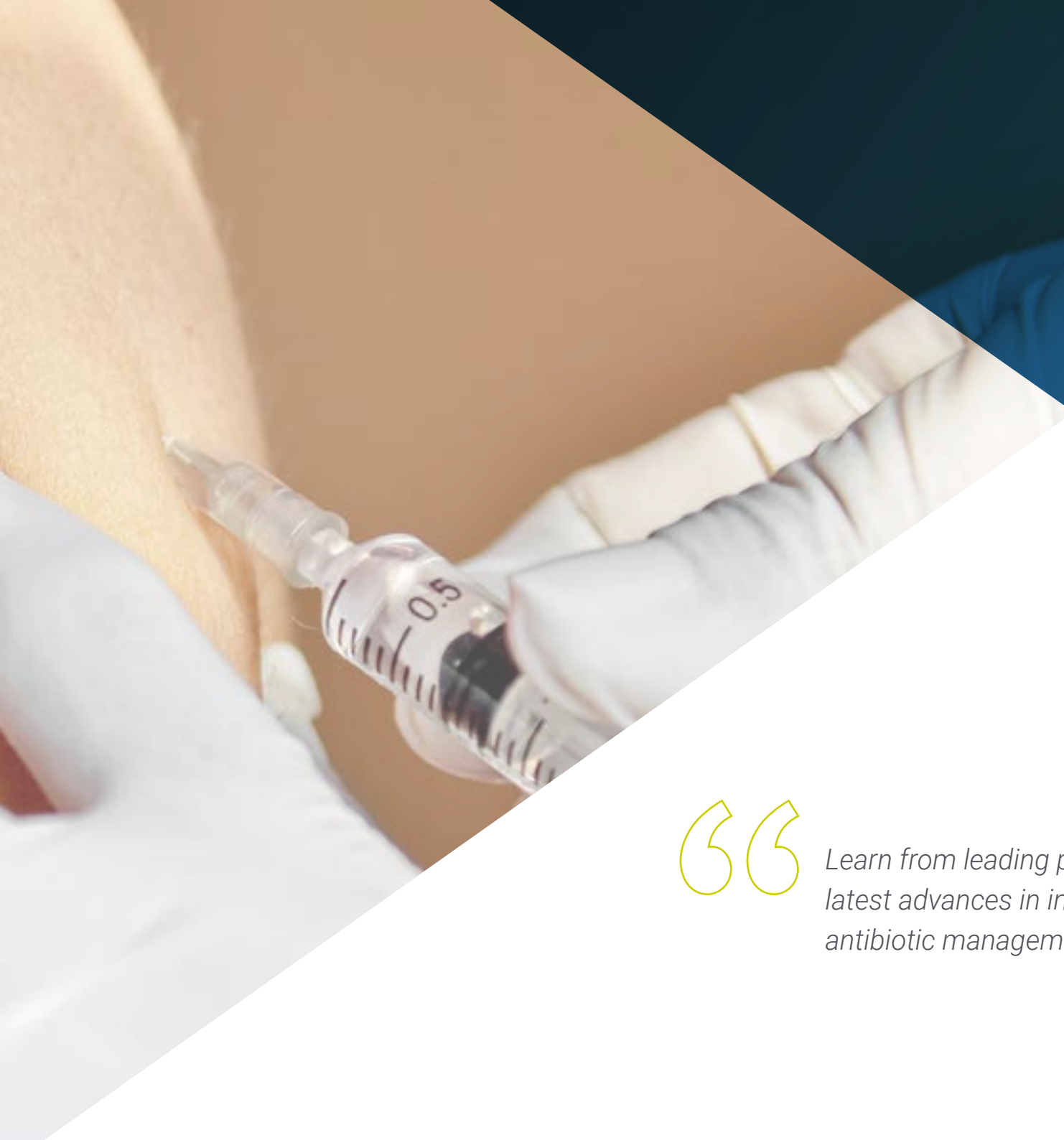
