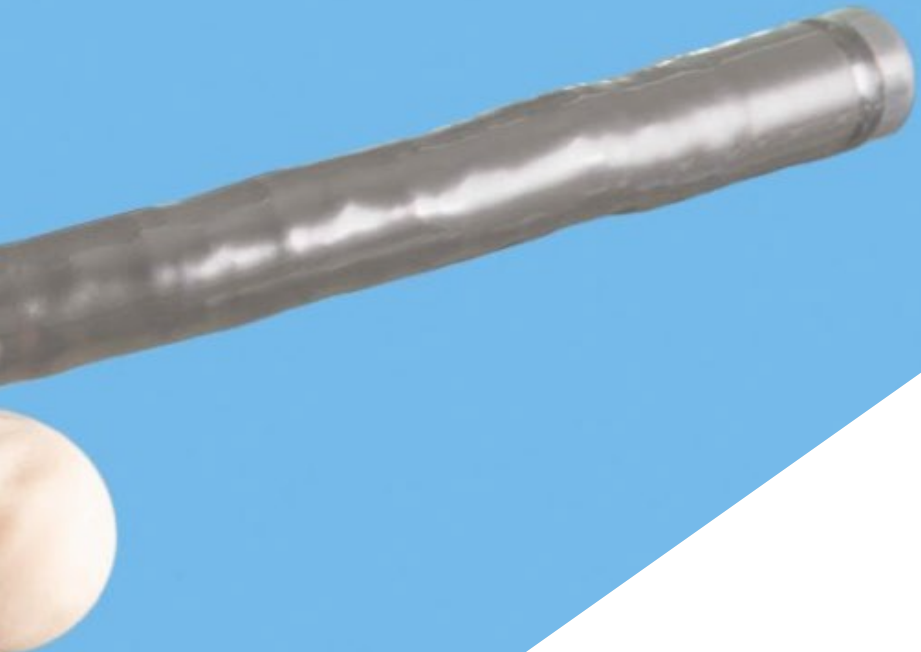


# 02 Objectives

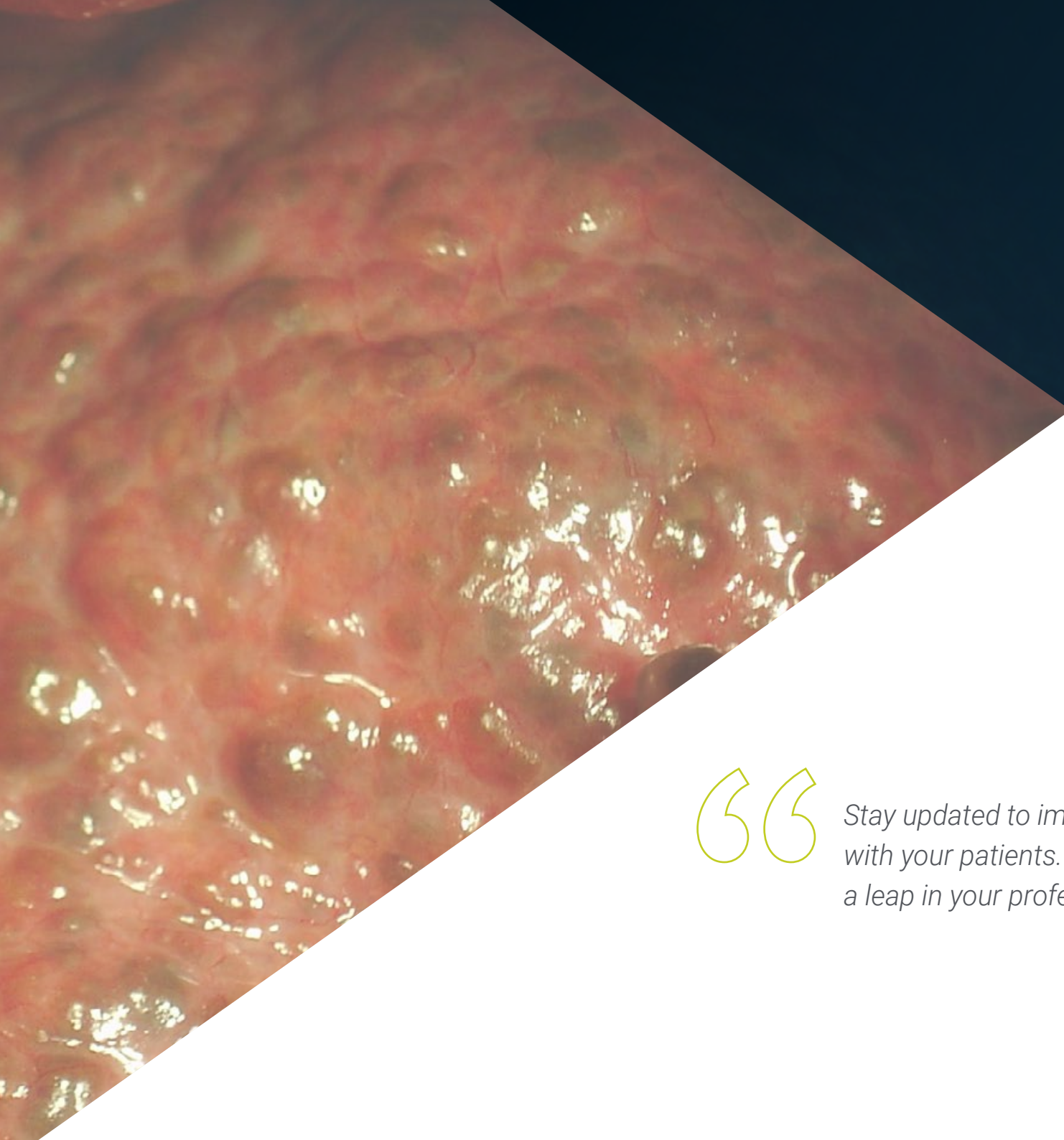
