# Methodology

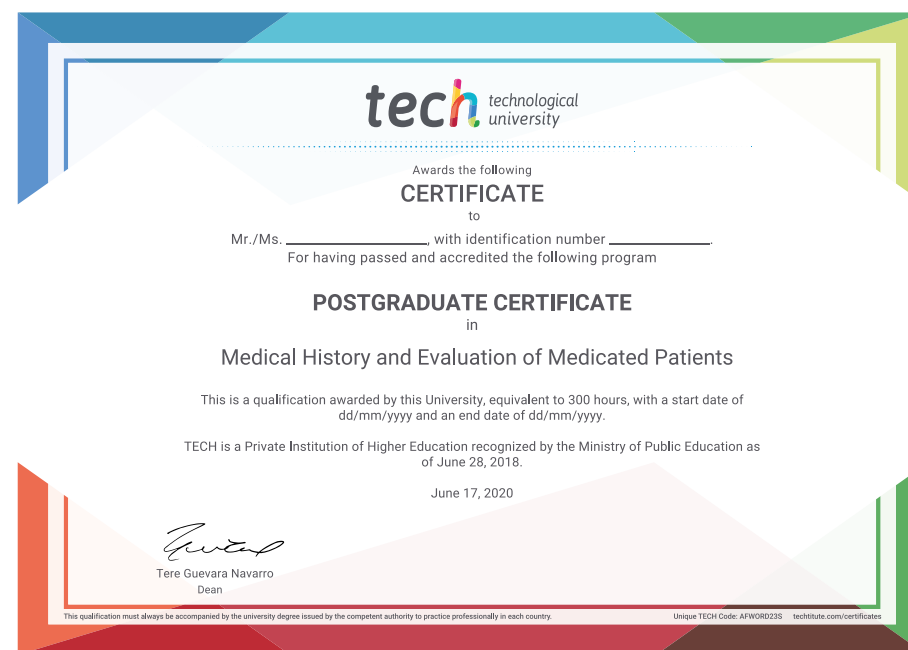
