# 01

# Introduction

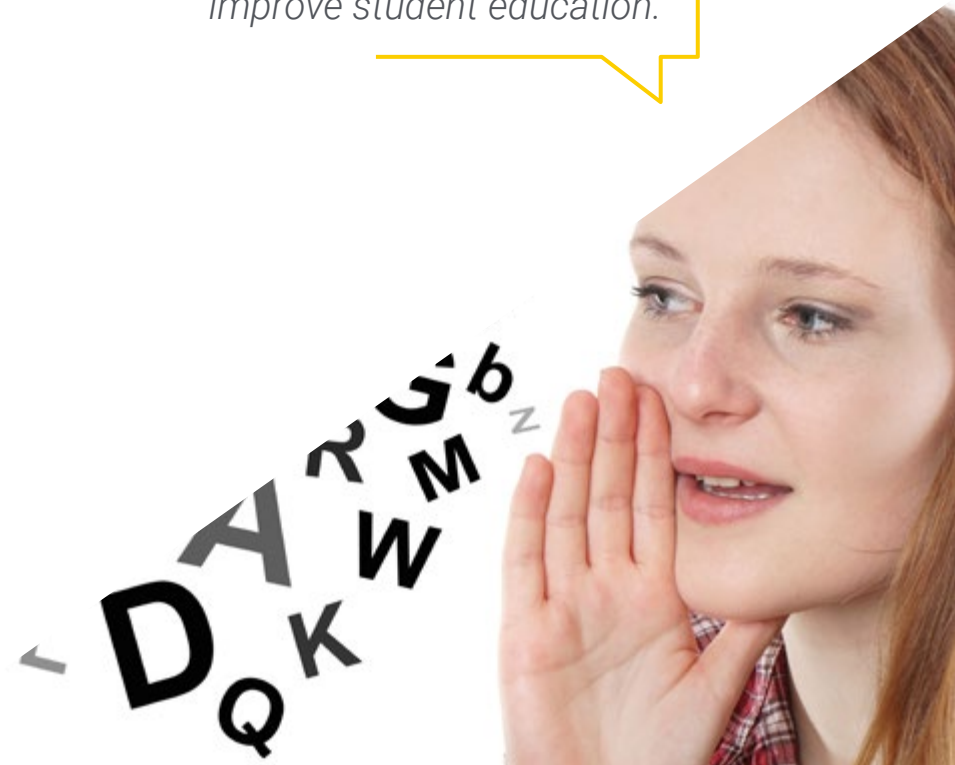

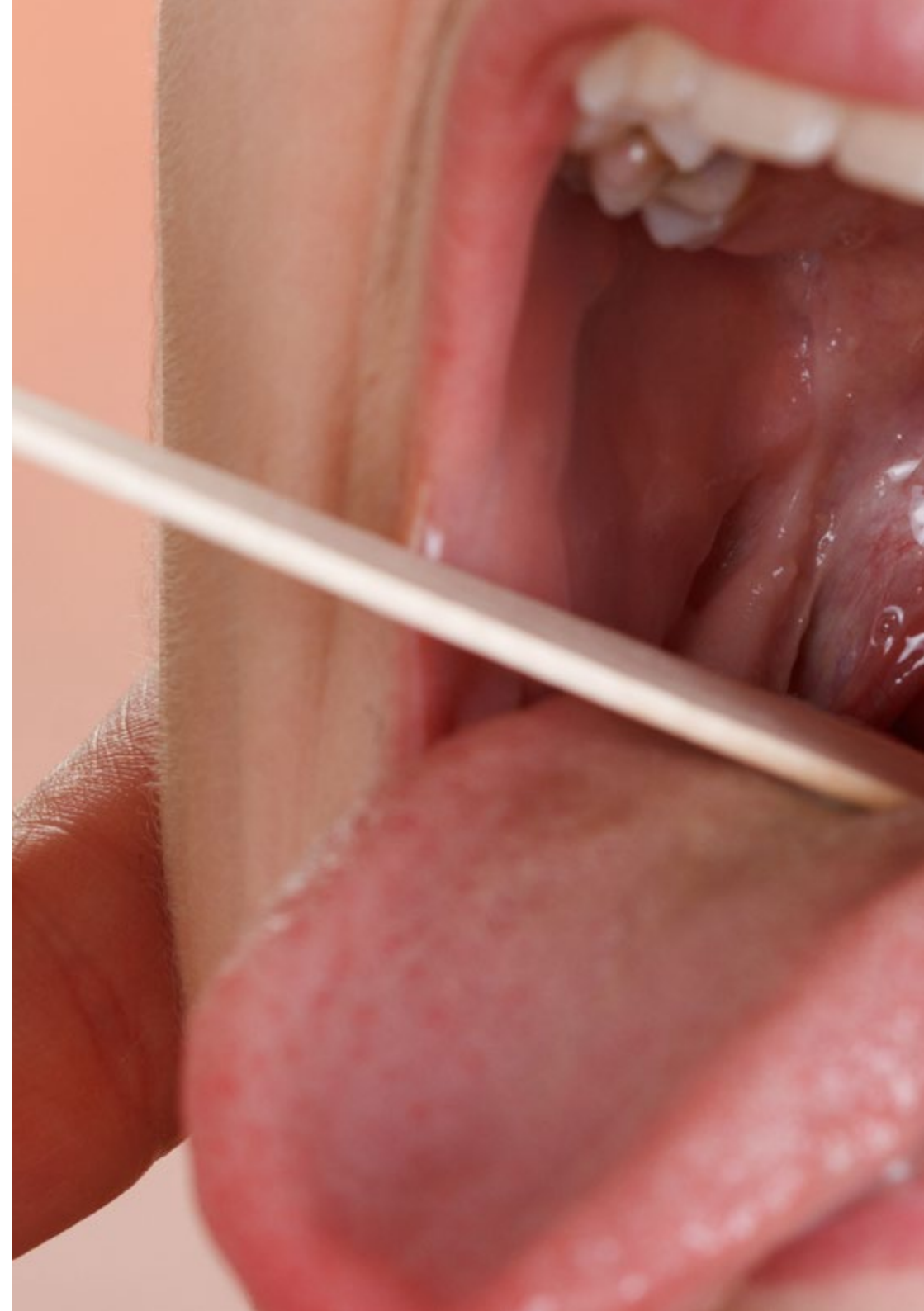

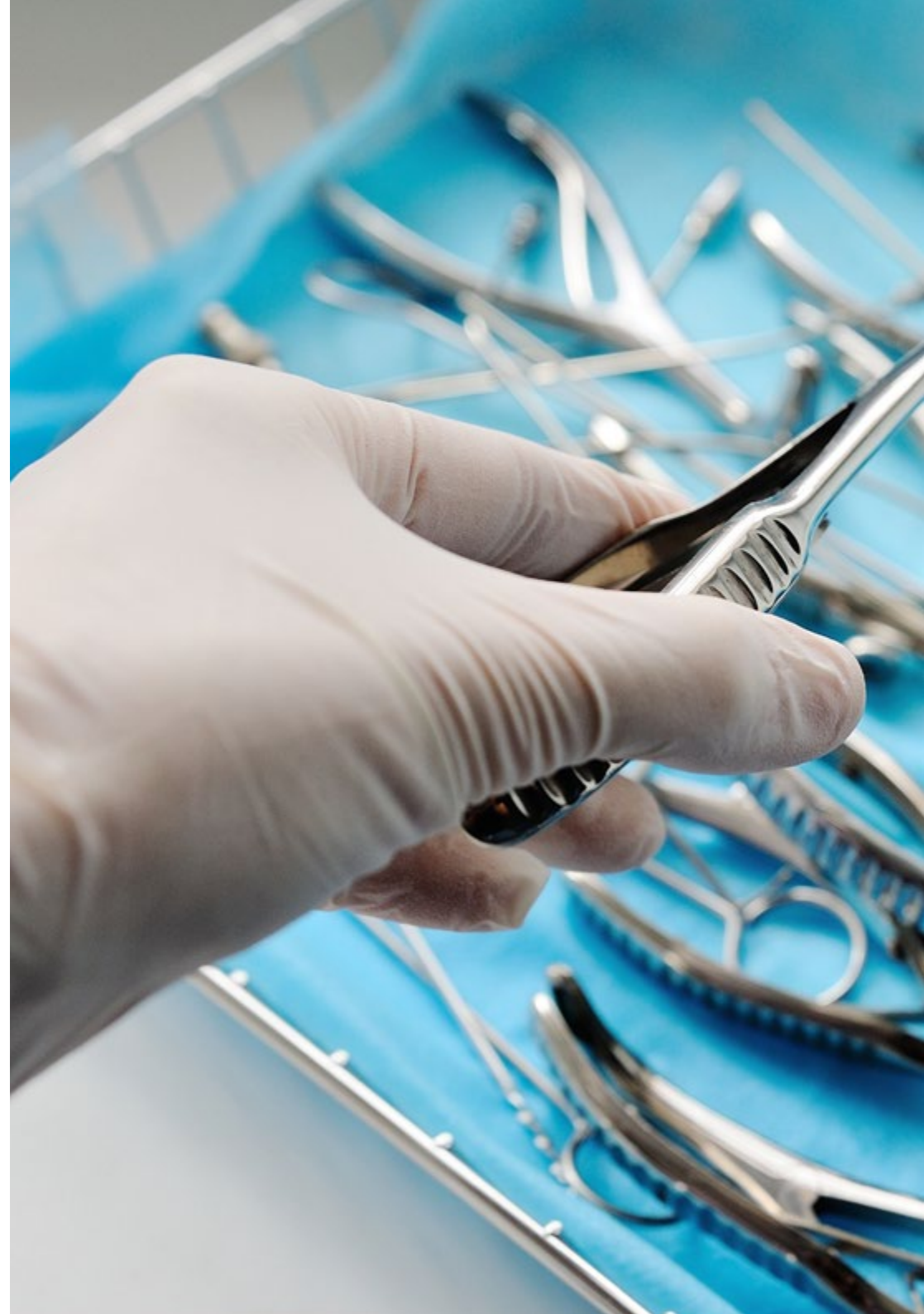
