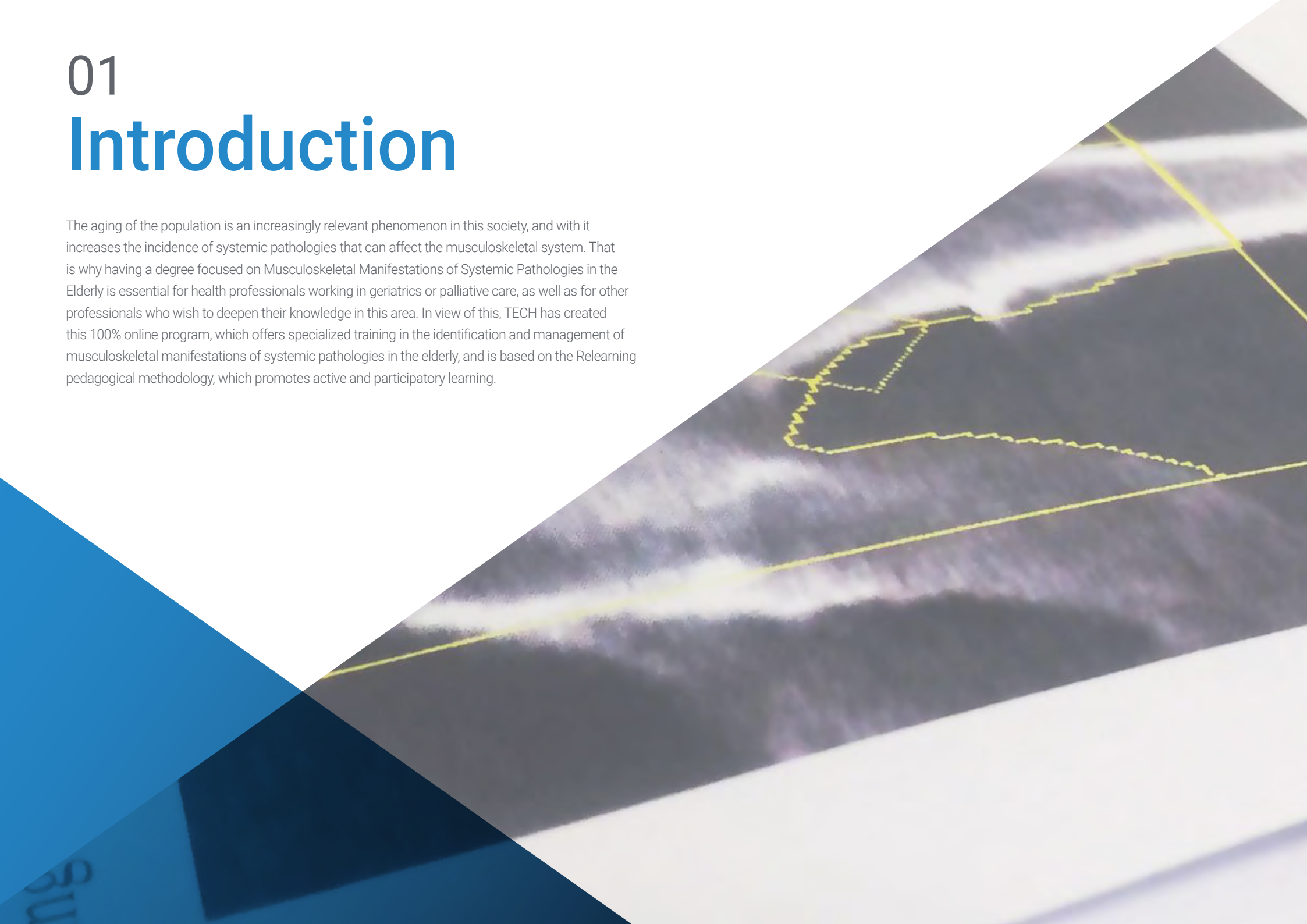

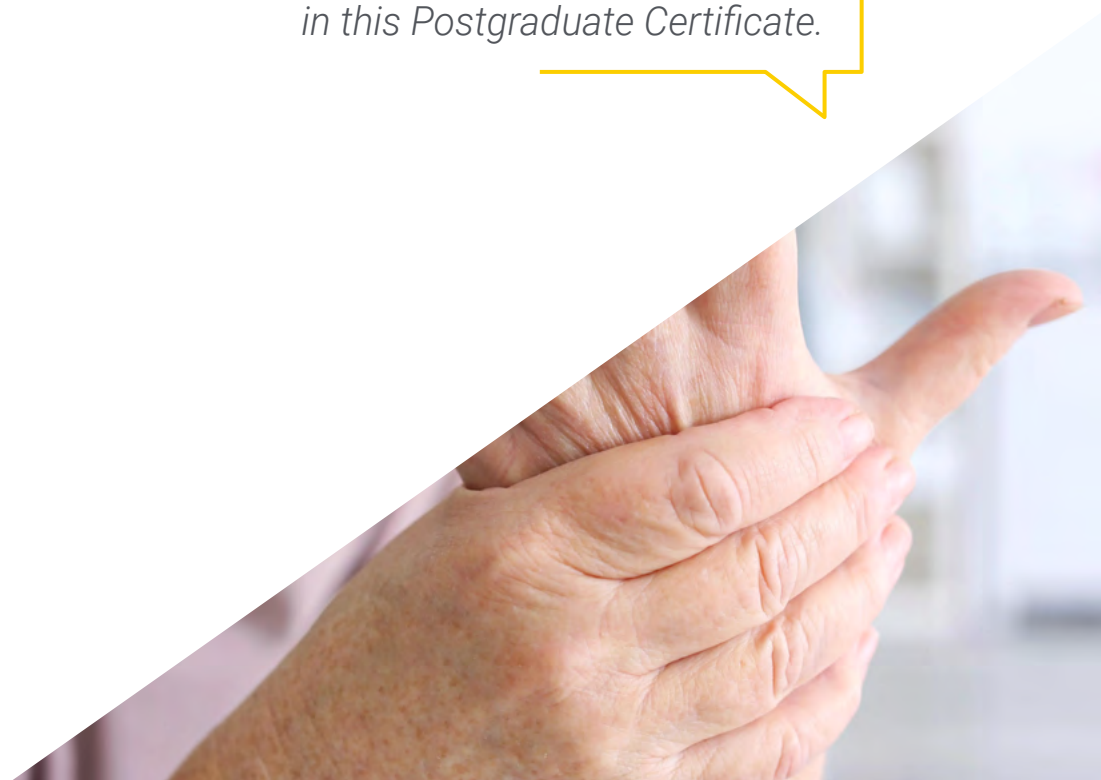

Structure and Content

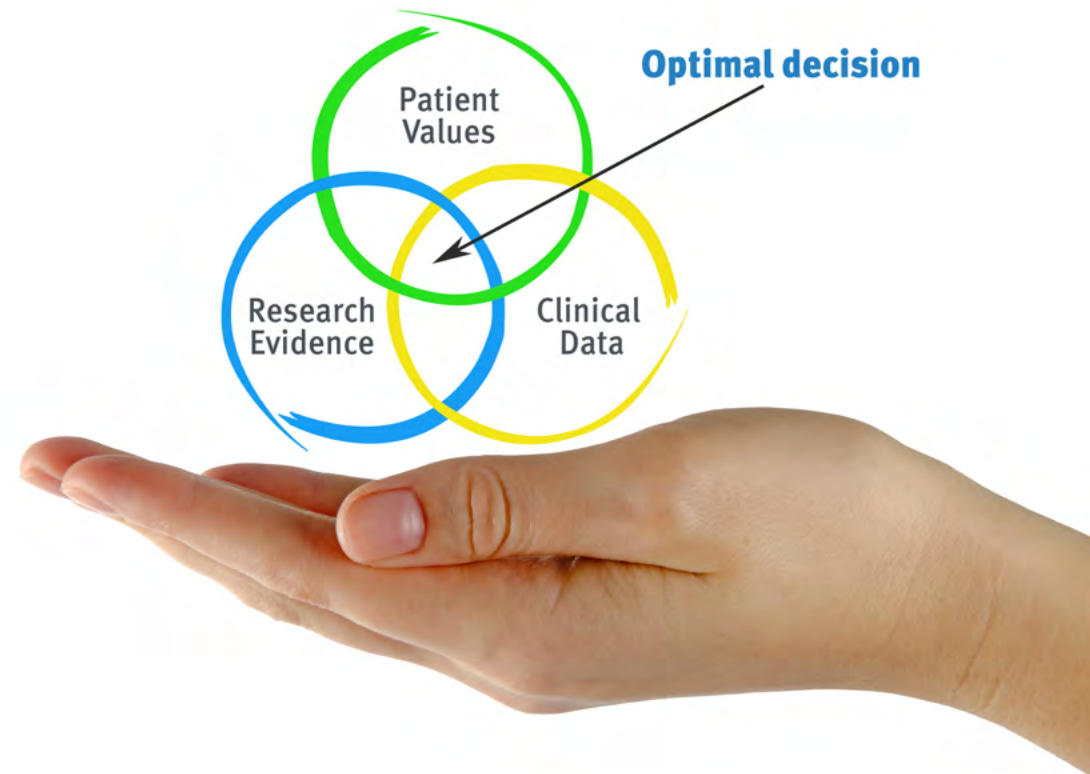

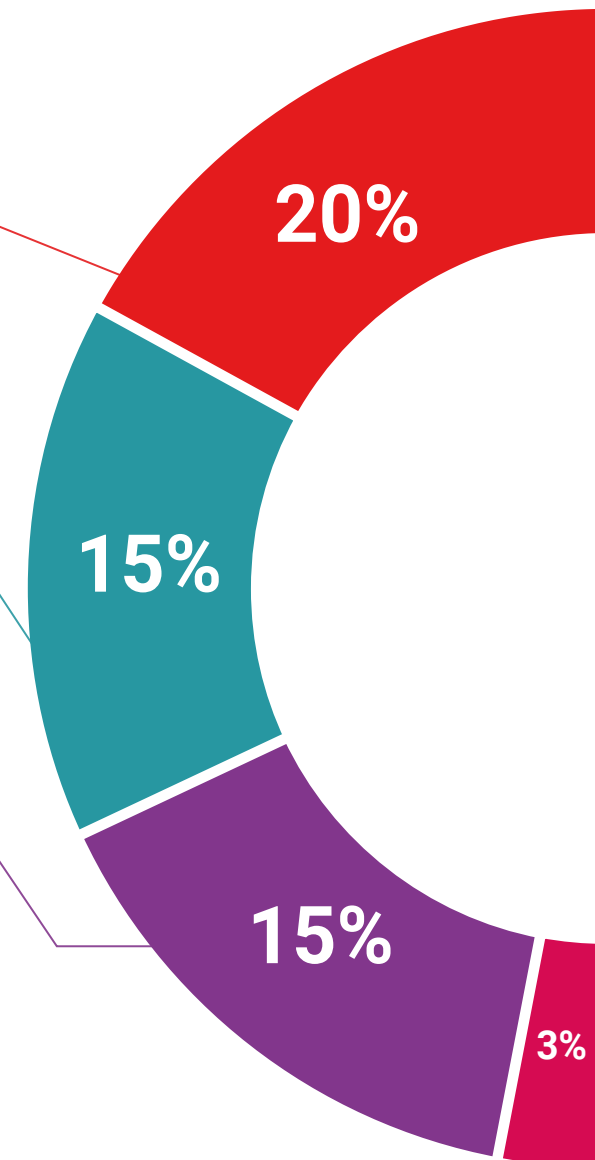
