# Introduction

Pharmacologic treatment is indicated in people with obesity (BMI  $\geq 30$  kg/m<sup>2</sup>) or overweight (BMI  $\geq 27$  kg/m<sup>2</sup>) in the presence of complications and in combination with lifestyle changes, but never alone.

The selection of the drug to be used should take into account the patient's characteristics, complications, differences in drug efficacy, side effects, drug interactions, precautions for use, as well as adherence rate.

It is a heterogeneous syndrome whose pathophysiology and etiopathogenesis (genetics, epigenetics, new hormonal control mechanisms, nutrigenomics, microbiomics, etc.) are continuously advancing. 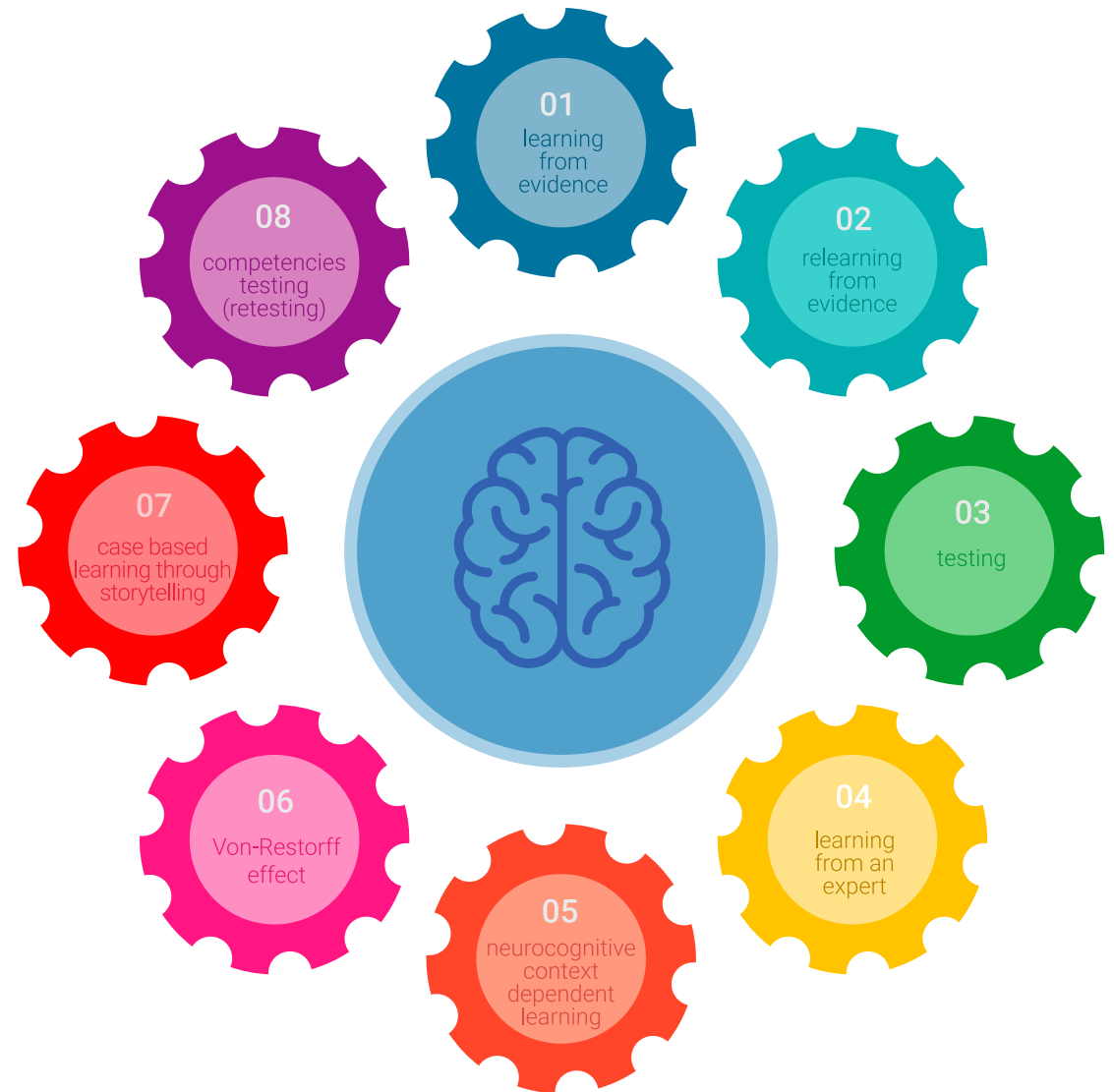

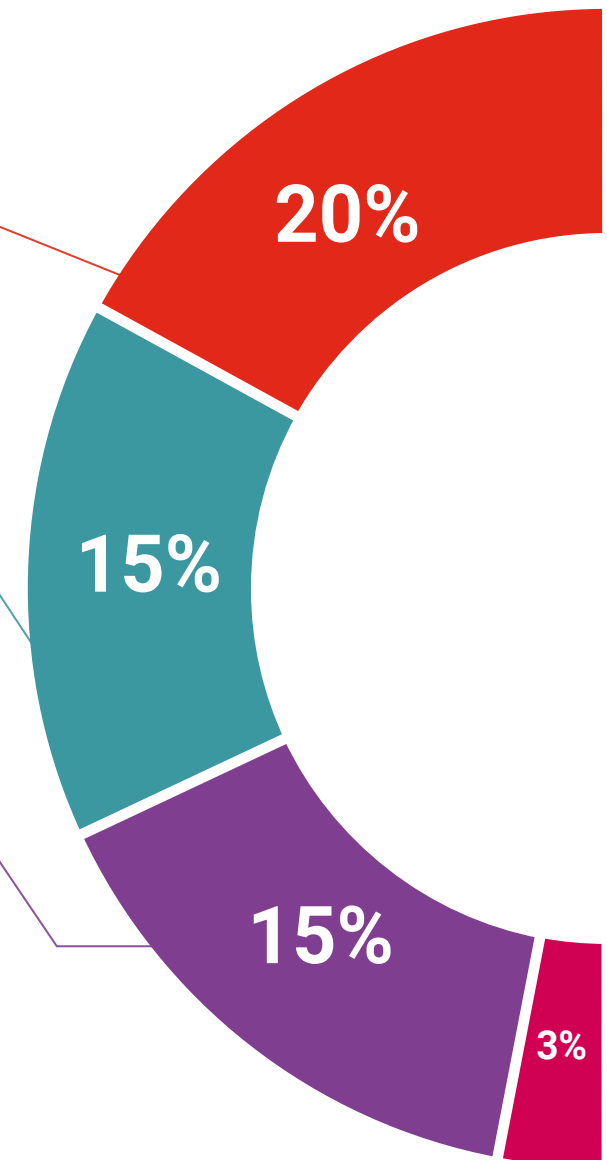

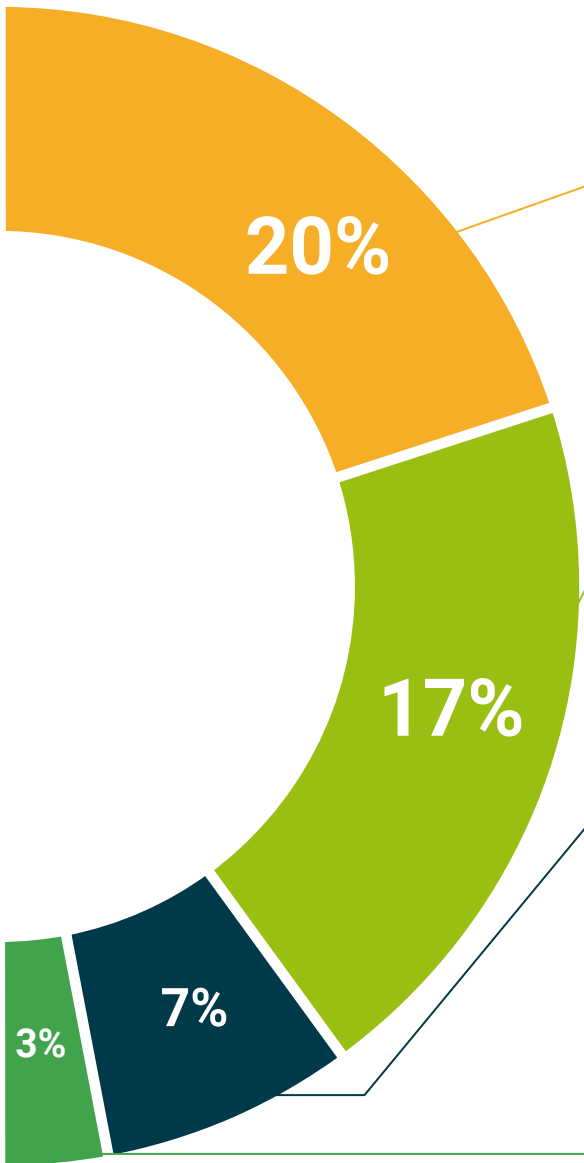
