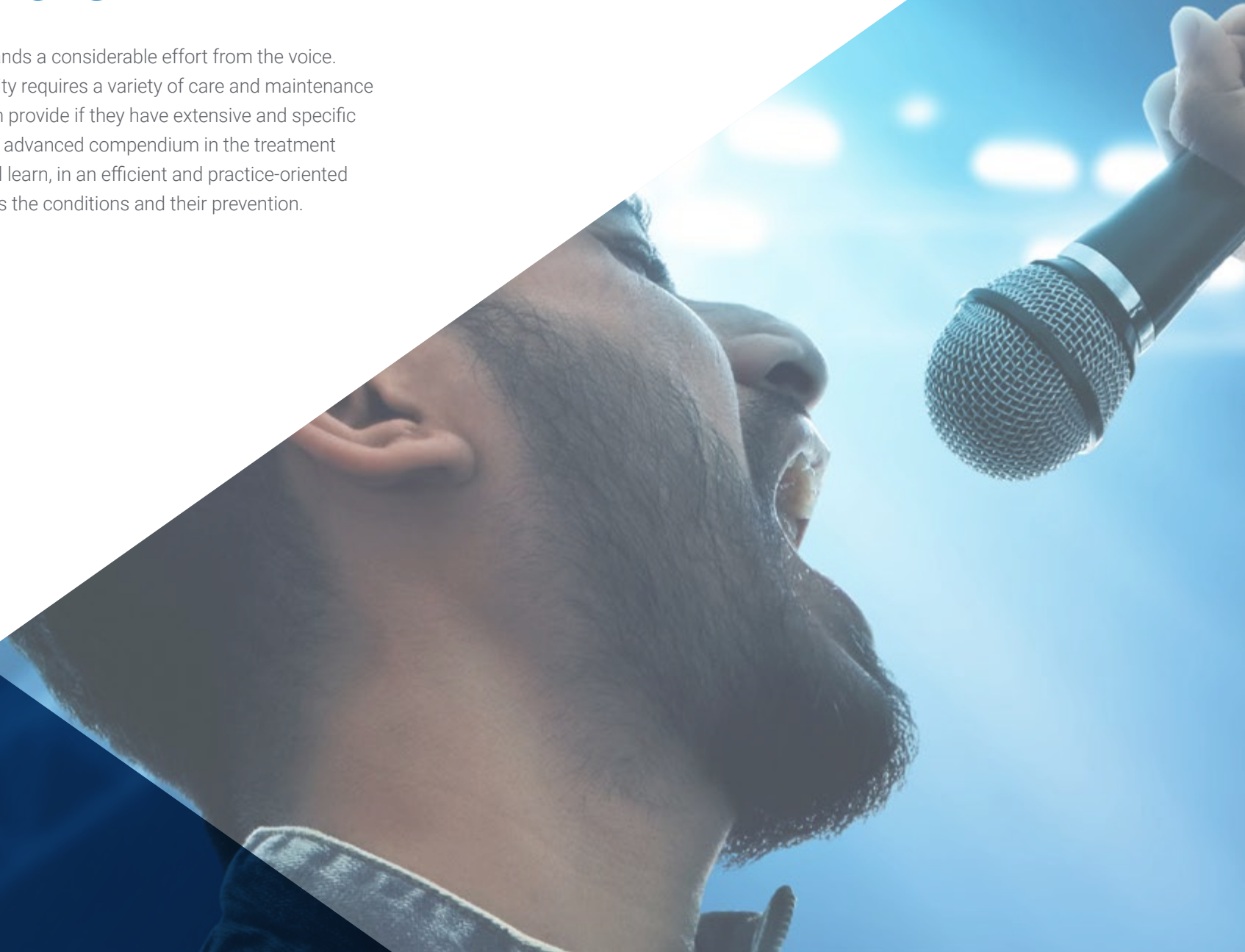

For all these reasons, knowledge about the use of voice, programs for the prevention of disorders, and Vocal Therapy applied to the use in different contexts are crucial elements for the health, well-being, and development of any speaker.

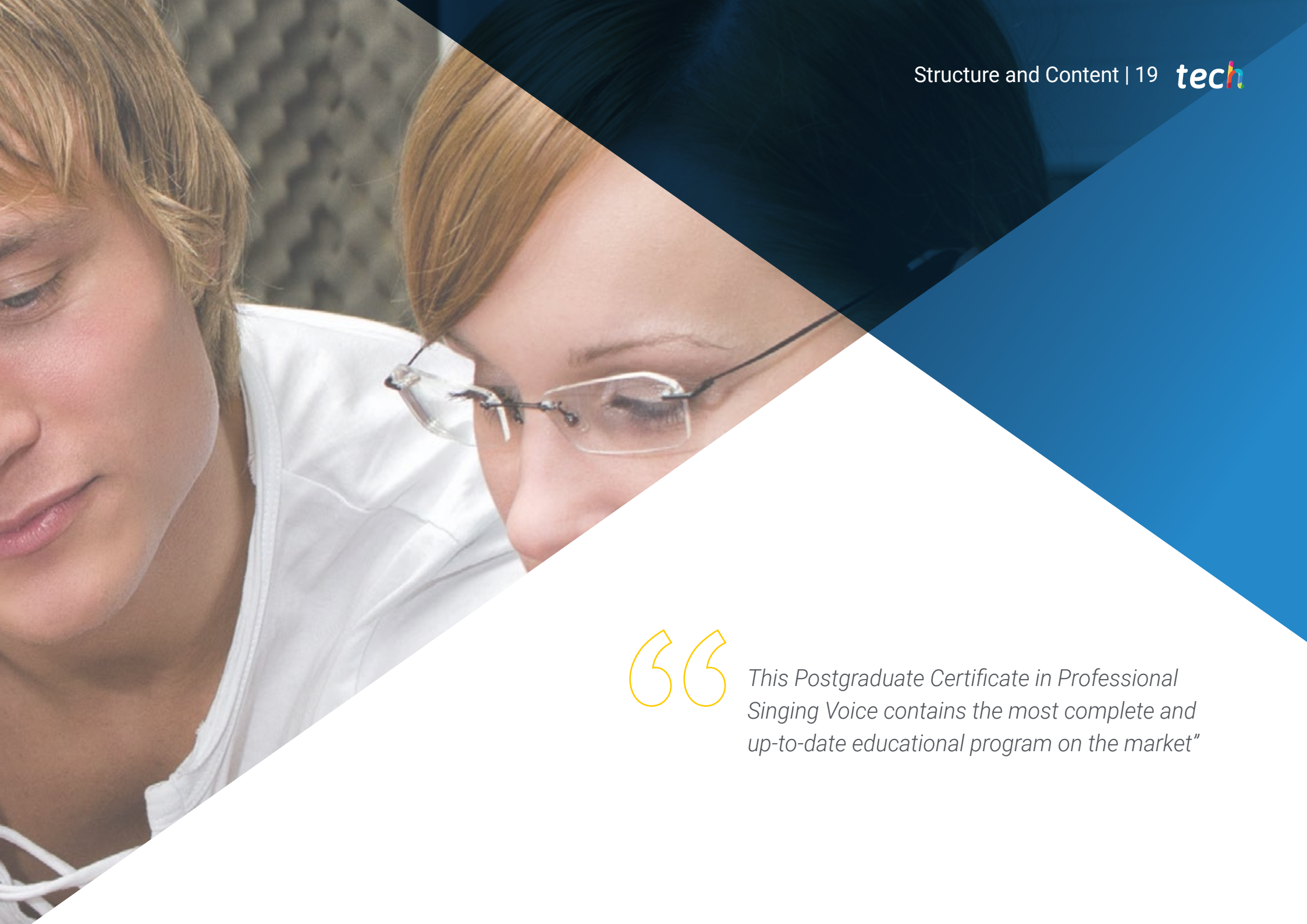
