Introduction

The treatment of severe burn patients is similar to that of other critically ill patients. However, they have some differential elements, such as the preparation for anesthesia required for multiple surgical interventions. In this Postgraduate Certificate, reference will be made to analgo-sedation and delirium (prevention and treatment), making an up-to-date presentation and marking the differences that correspond to these patients.

The most current information on the effects of vitamin C macrodoses to decrease the inflammatory response in these patients will be shown below. Likewise, the therapeutic attempts that have been made to try to avoid the complications of inhalation syndrome will be discussed. There will also be a section dedicated to the specific treatment of electrical burns and their multiple possible complications.

Finally, this Postgraduate Certificate covers the treatment of critical patients in the burn unit, without forgetting two pathologies that are usually treated in these units, even if they are not caused by burns, such as necrotizing infections of soft parts and toxic epidermal necrolysis.

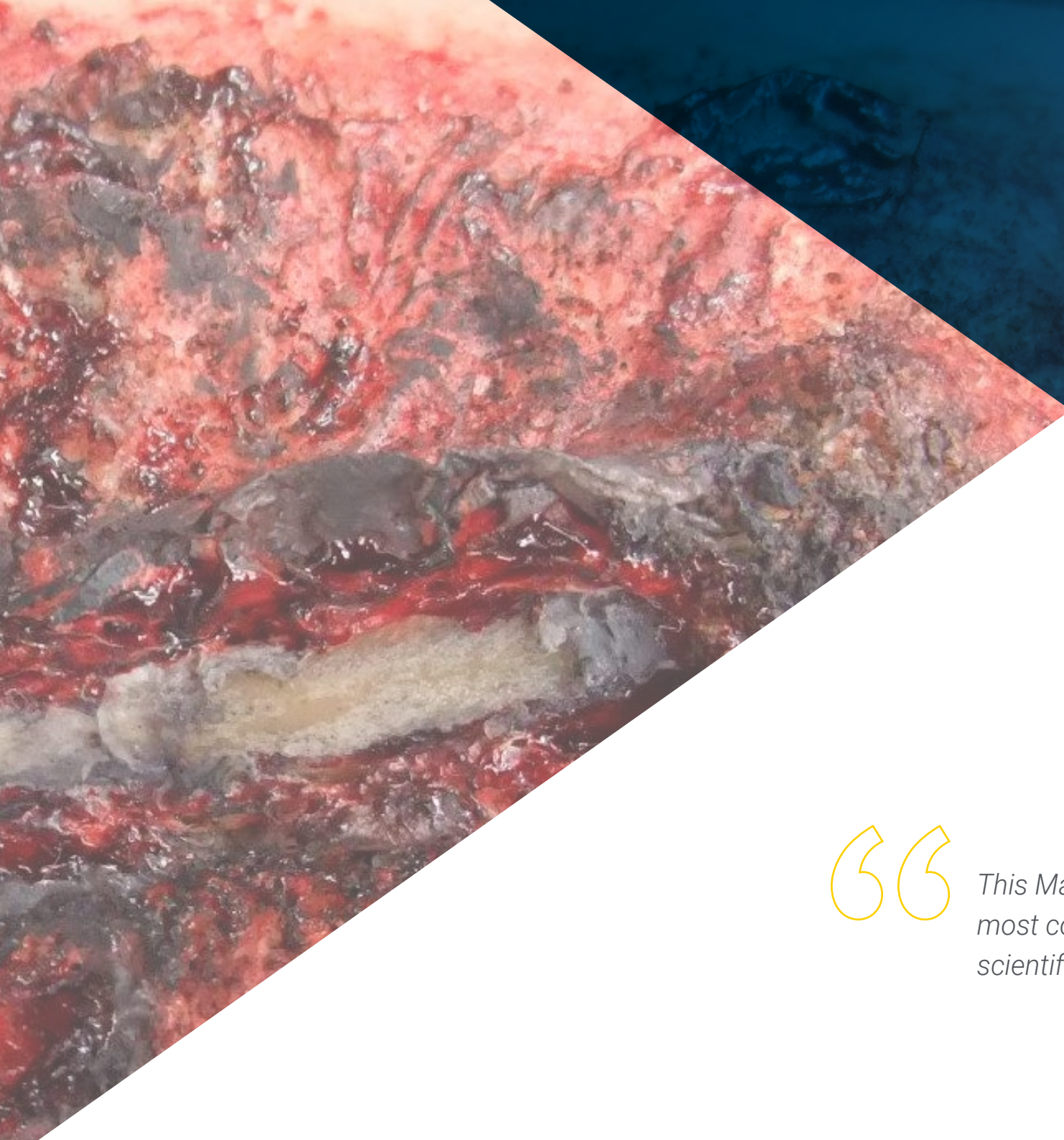

05 Methodology

Did you know that this method was developed in 1912, at Harvard, for law students? The case method consisted of presenting students with real-life, complex situations for them to make decisions and justify their decisions on how to solve them. In 1924, Harvard adopted it as a standard teaching method”

The effectiveness of the method is justified by four fundamental achievements:

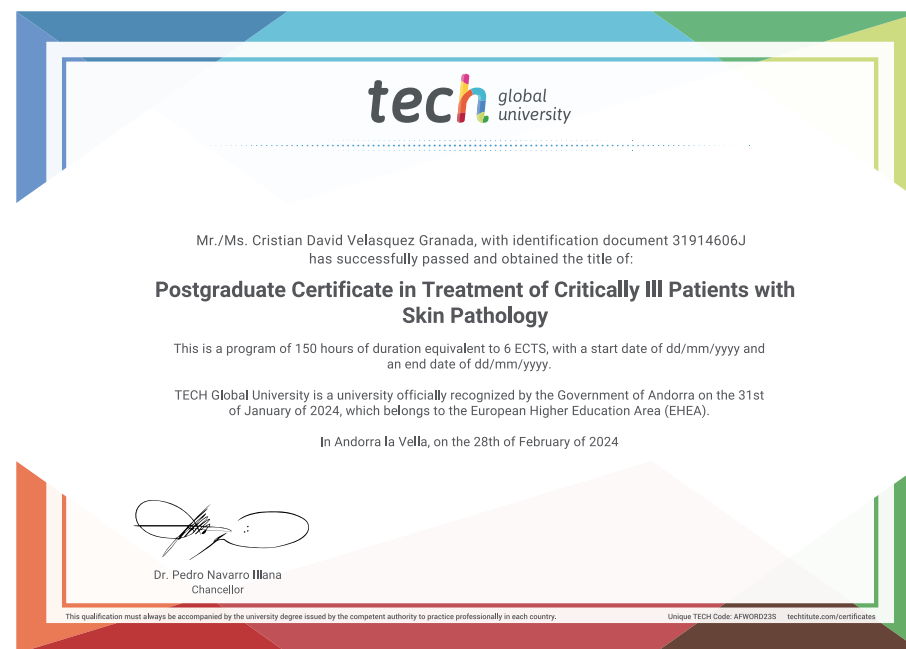
