Arteriosclerosis is the highest risk factor for vascular pathology of the eye and its functional structures. Thrombosis, venous and arterial embolisms make up the most important risk group for retinal obstructive events, which is also increased by age. Diagnosis and prognosis depend largely on the location of the thrombus, in the retina or in the veins inside the eye.

In the case of tumor pathologies, one of the most relevant aspects that the specialist must control is its origin, ocular or extraocular, which will determine more clearly its possible prognosis, evolution and treatment. Whether they are primary tumors, which grow directly in the eye, or metastatic or secondary tumors, the specialist needs to know how to intervene in an early and adjusted way in their treatment.

Symptoms of ocular injury or pathology can range from a small defect in the field of vision to a more acute loss of visual acuity. Early detection means a considerable improvement in the prognosis of vascular and tumor conditions.

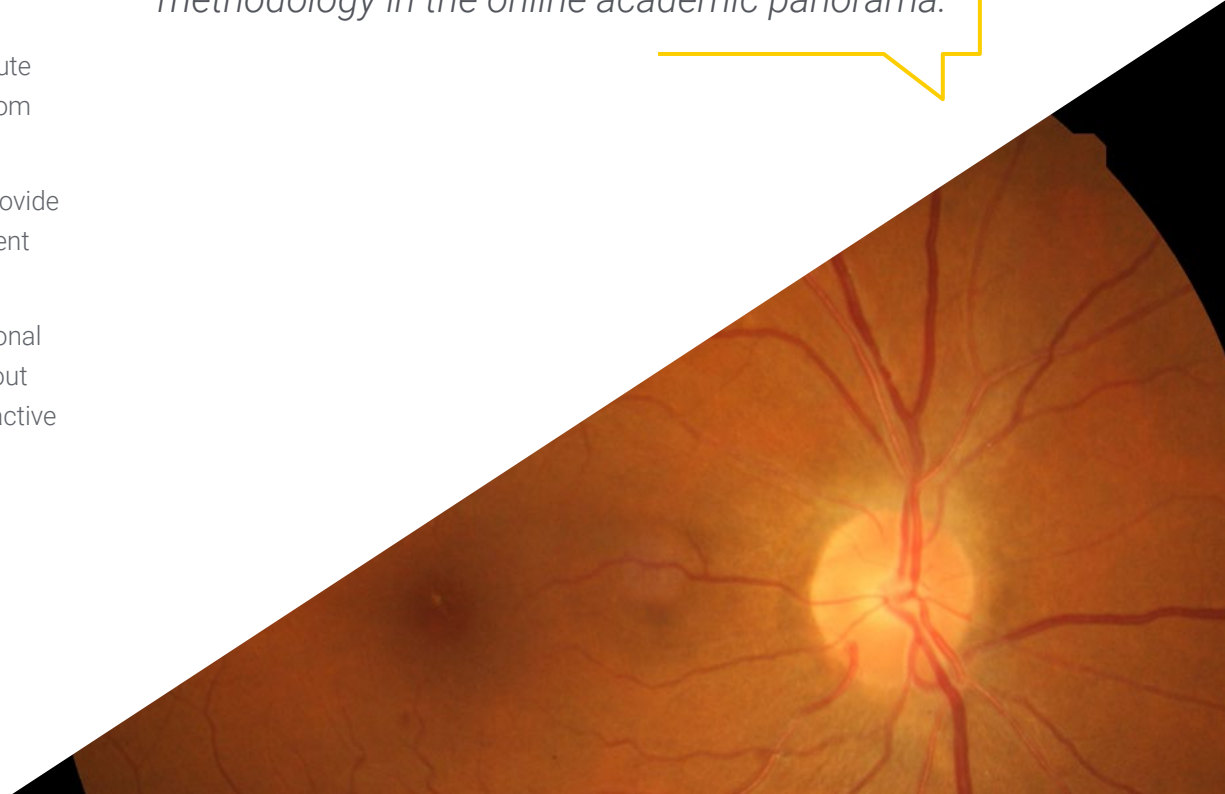

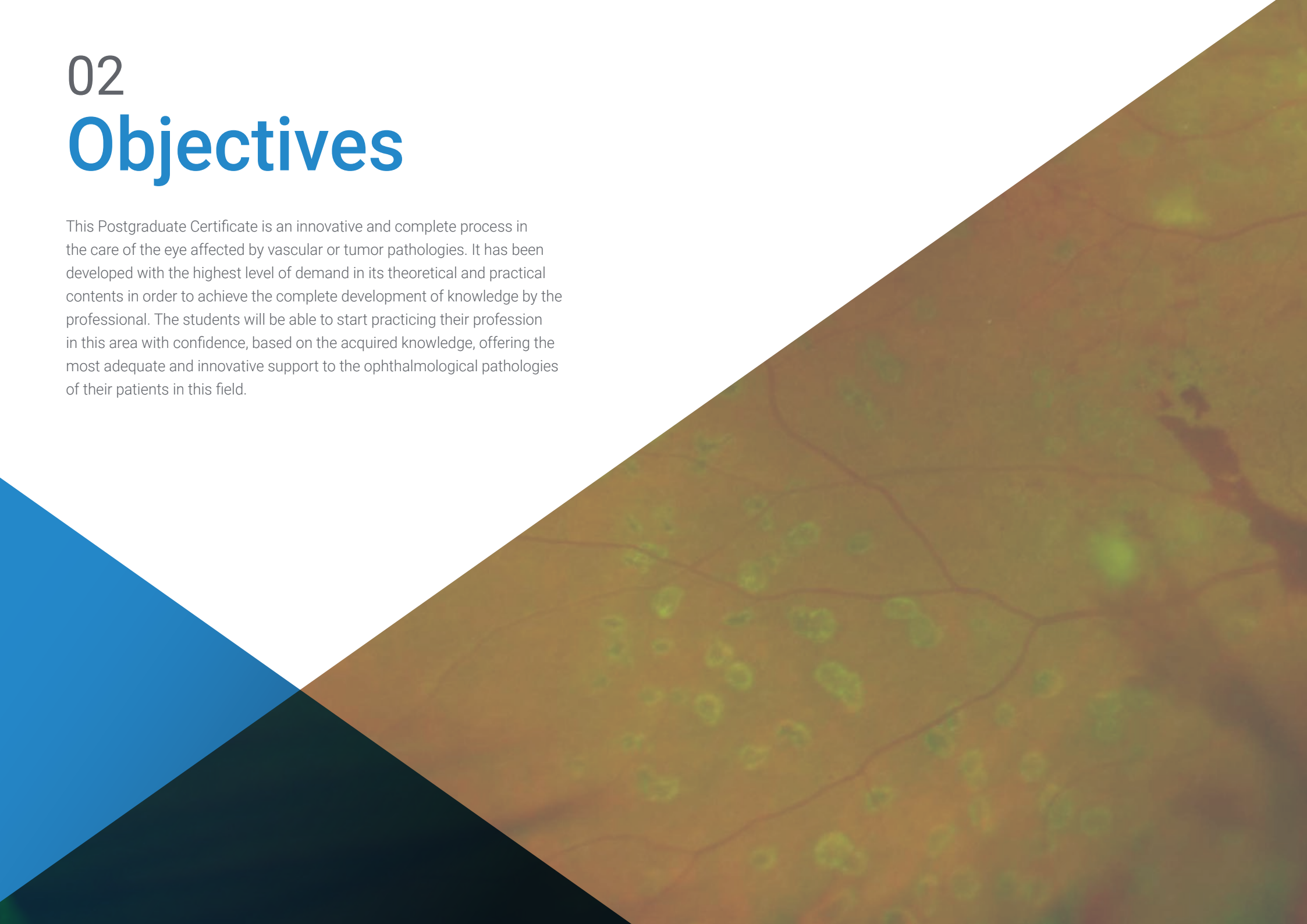

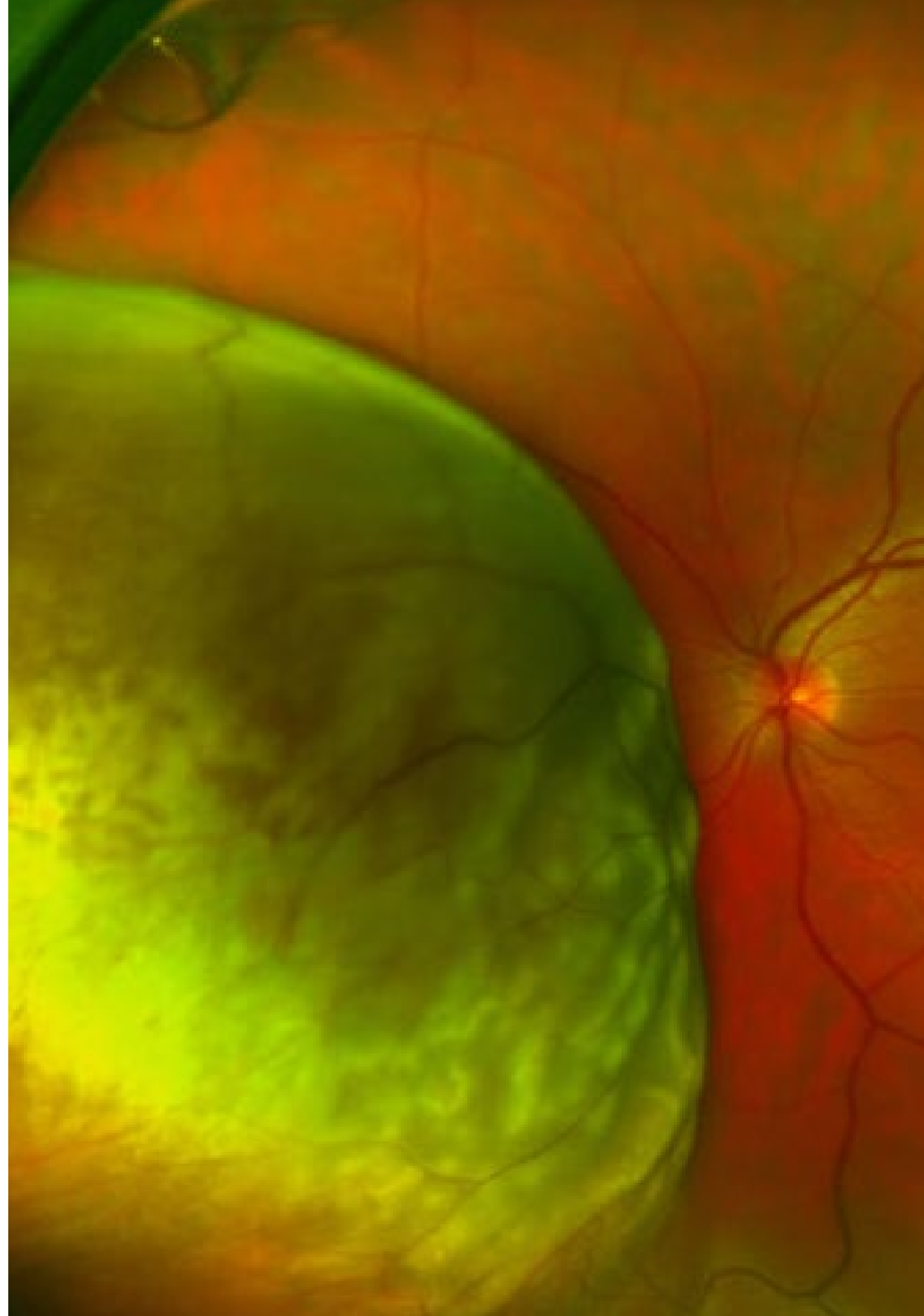
