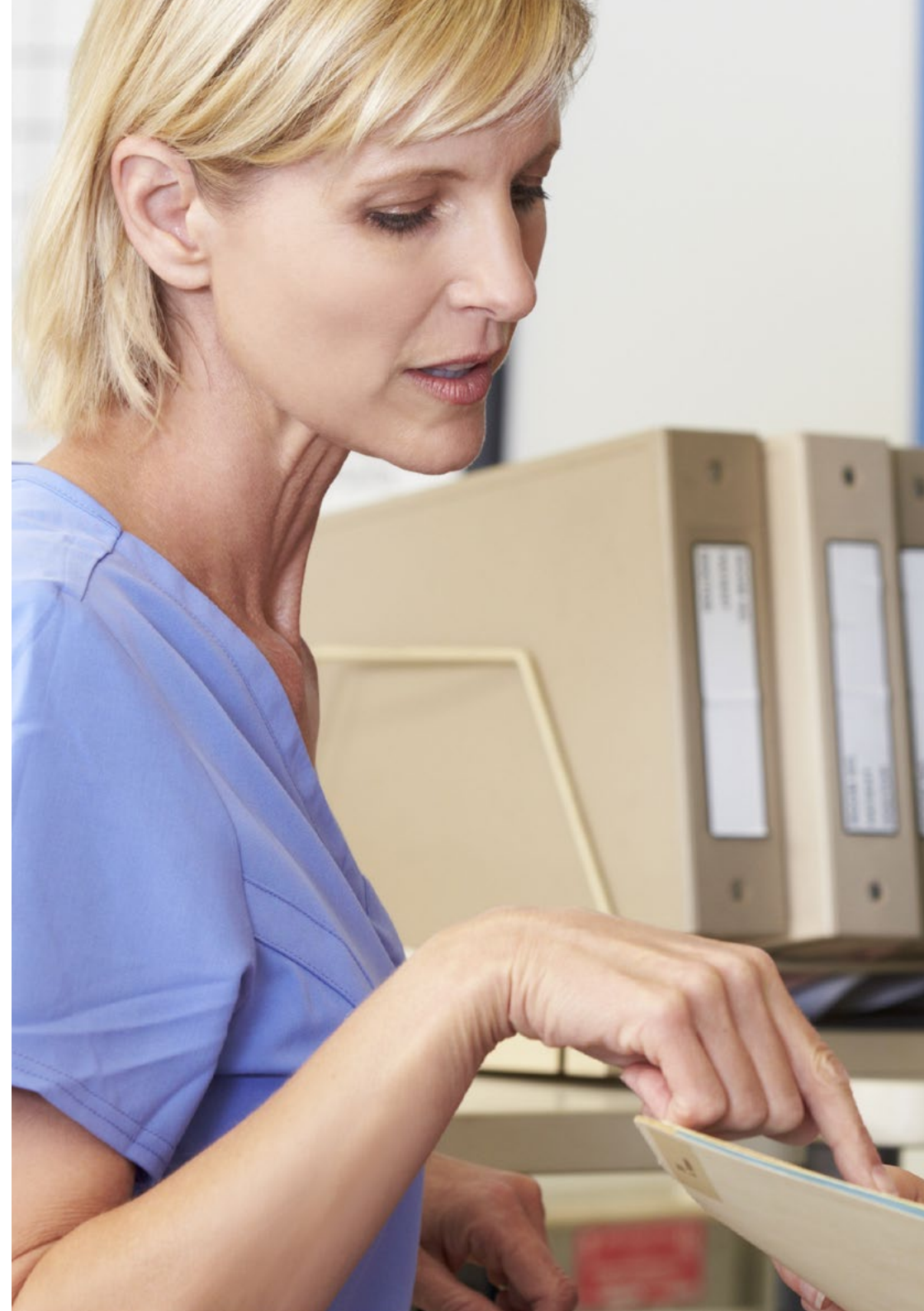

Methodology
