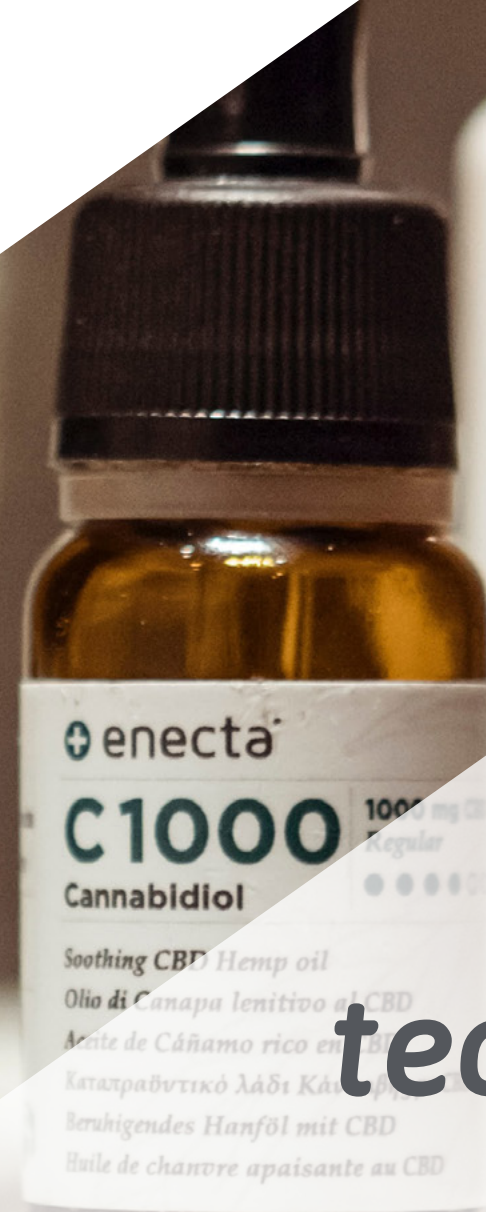

# Introduction

When conducting research, it is necessary to have the appropriate regulatory framework to respond to new scientific challenges, while protecting the rights of those who may be affected. Biomedical Research in Health Sciences is a key instrument to improve and raise the quality of life, life expectancy and well-being of citizens.

However, the interests of the participants must take precedence over any other interest, an aspect included in the November 12 41/2022 Law, which regulate patient autonomy and the rights and obligations regarding clinical information and documentation.

Informed consent becomes an essential element when the preclinical phases of research have been completed and the subject voluntarily expresses their intention to participate in research, after having understood the information provided about the research.

The Independent Clinical Research Support Office is the point of contact at the Spanish Agency of Medicines and Medical Products (AEMPS) for investigators and sponsors of non-commercial studies to receive advice on different aspects: technical, regulatory or administrative, when necessary.

The AEMPS, as a state agency attached to the Ministry of Health, is responsible for guaranteeing, from a public service perspective, the quality, safety, efficacy and reliable information about medications and medical devices, from their research to their use, in the interest of protecting and promoting social health.

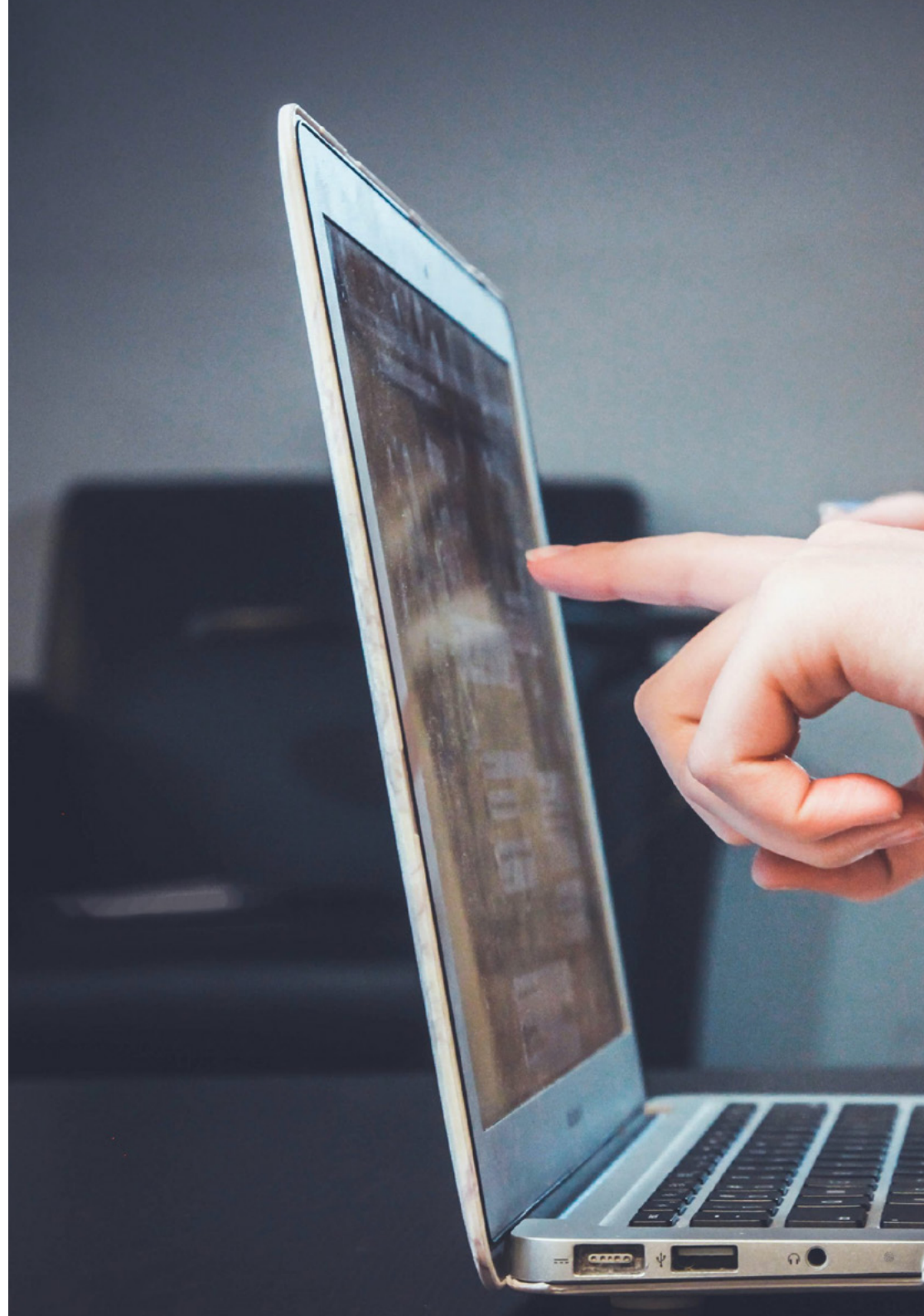

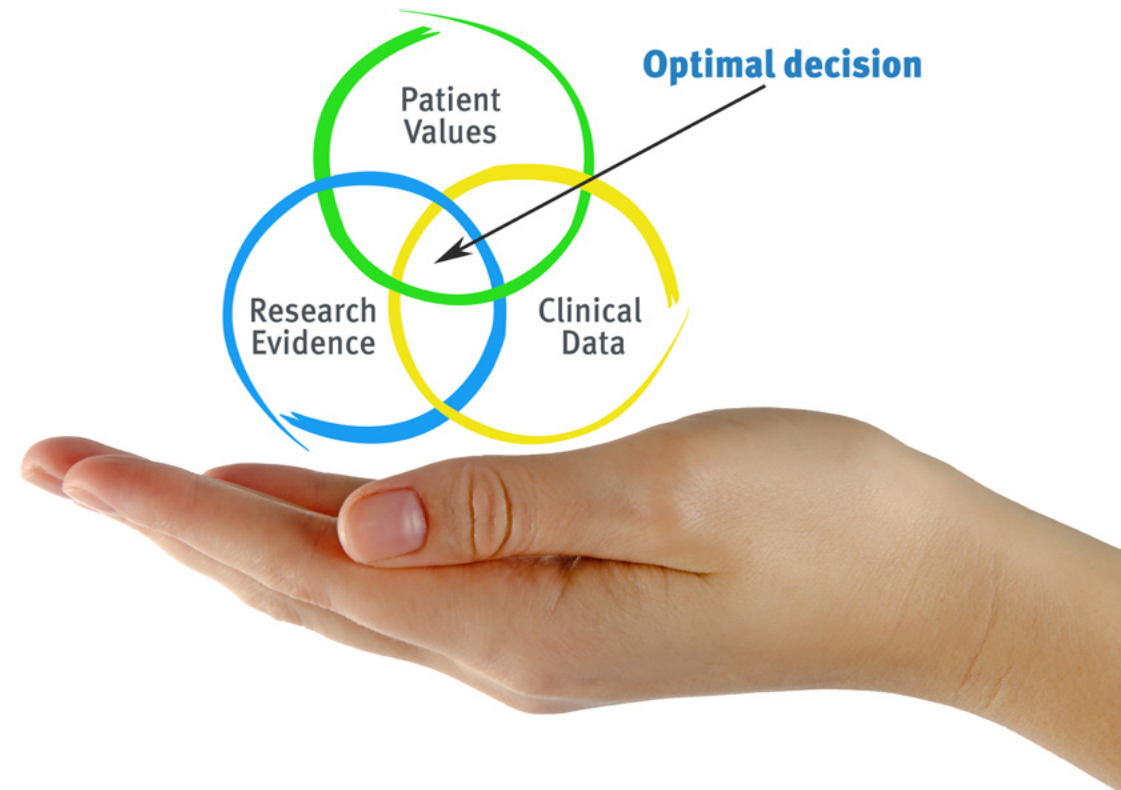

## At TECH Nursing School we use the Case Method

In a given situation, what should a professional do? Throughout the program, students will face multiple simulated clinical cases, based on real patients, in which they will have to do research, establish hypotheses, and ultimately resolve the situation. According to Dr. Gérvas, the clinical case is the annotated presentation of a patient, or group of patients, which becomes a "case", an example or model that illustrates some peculiar clinical component, either because of its teaching power or because of its uniqueness or rarity. It is essential that the case is based on current professional life, in an attempt to recreate the real conditions in professional nursing practice.

In 1924, Harvard adopted it as a standard teaching method”*

The effectiveness of the method is justified by four fundamental achievements:

1. Nurses who follow this method not only grasp concepts, but also develop their mental capacity, by evaluating real situations and applying their knowledge.
2. The learning process has a clear focus on practical skills that allow the nursing professional to better integrate knowledge acquisition into the hospital setting or primary care.
3. Ideas and concepts are understood more efficiently, given that the example situations are based on real-life.

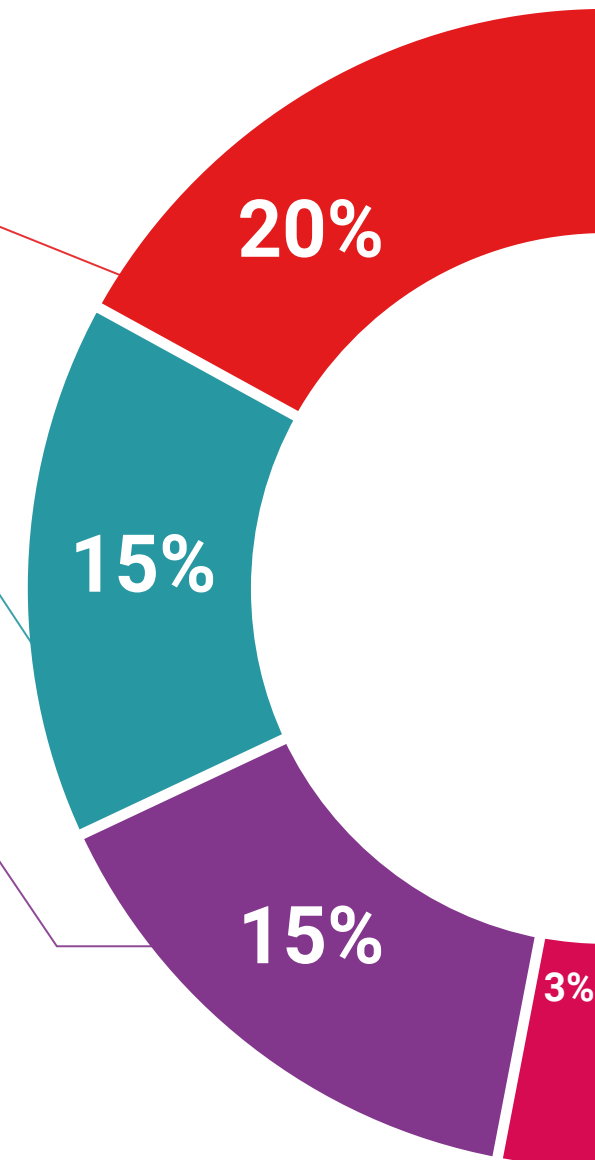
