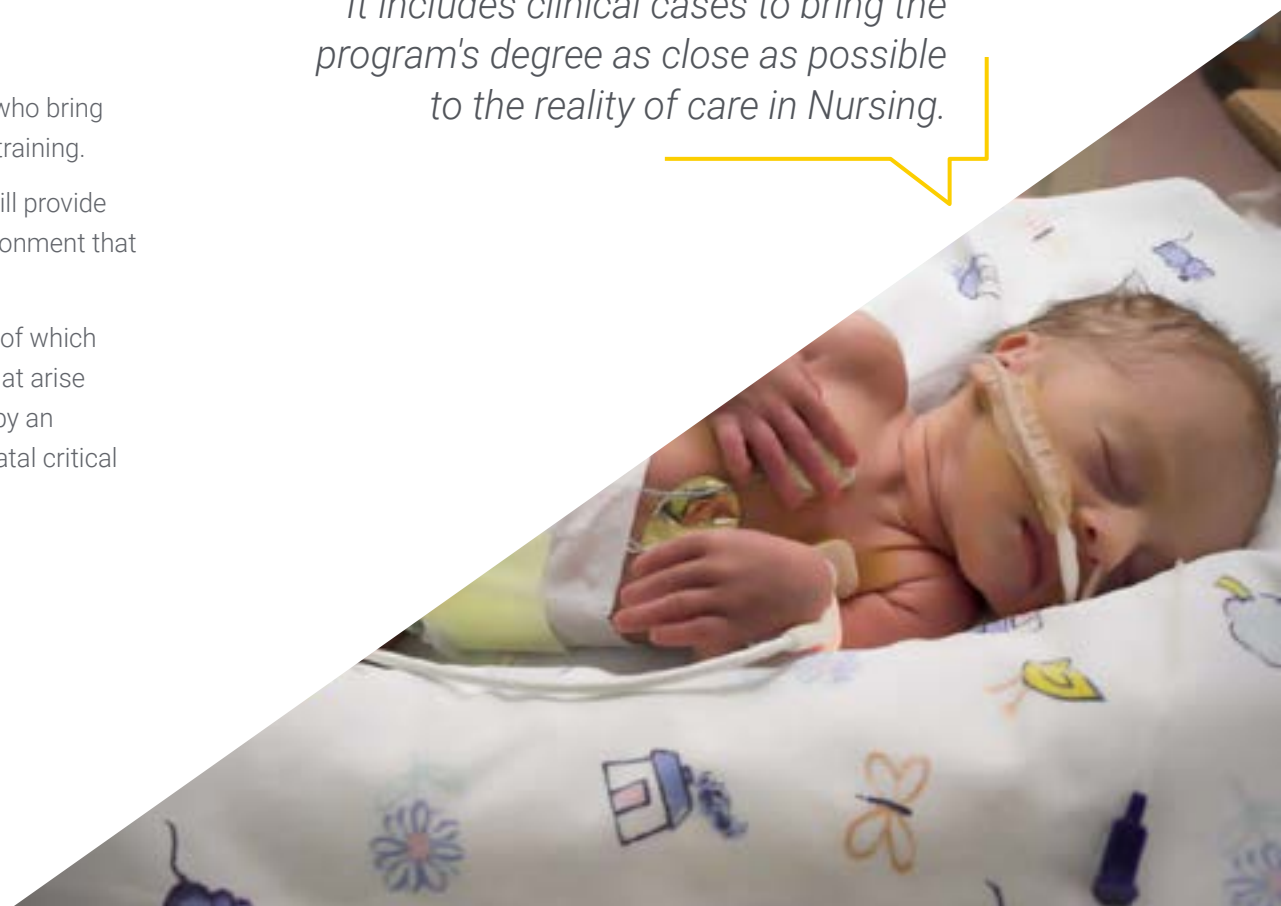

- ♦ Know the differences between the neonate, the child and the adolescent (pediatric ages).
- ♦ Differentiate between the different neonatal stages, as well as neonatal stages by gestational age and neonatal stages by birth weight.
- ♦ Review the anatomical and physiological characteristics of the normal newborn.
- ♦ Describe the somatometry of the newborn, as well as its morphological and physiological characteristics.
- ♦ Assess the complete examination, sequence of physical examination and complete physical examination of the newborn, focusing primarily on the head and neck region, trunk region and extremities region.
- ♦ Update procedures for performing a complete neurological examination of the neonate.
- ♦ Evaluate how a neonatology service is structured and organized, as well as its location, the necessary equipment and materials, and the necessary human resources.
- ♦ Describe the characteristics of the neonatal intensive care unit (NICU), and calculate the layout of the cribs, the necessary physical space, equipment and materials, and adequate human resources.
- ♦ Define the profiles and positions of the "nursing team" as well as its operating system: "Primary Nursing" (Head Nurse)
- ♦ Update the procedures for neonatal resuscitation, assessing neonatal risk factors, as well as general measures in the moments prior to delivery.
- ♦ Record how a resuscitation team is formed, as well as the equipment necessary to perform neonatal resuscitation.
- ♦ Review resuscitation procedures
- ♦ Describe and explain respiratory support modalities.
- ♦ Update cardiac massage technique
- ♦ Review medication administration procedures in neonatology.
- ♦ Assess the action in a neonatal cardiorespiratory arrest.
- ♦ Detect special resuscitation situations, as well as the basic principles of successful resuscitation.
- ♦ Assess possible complications that may arise during neonatal resuscitation.

Methodology
