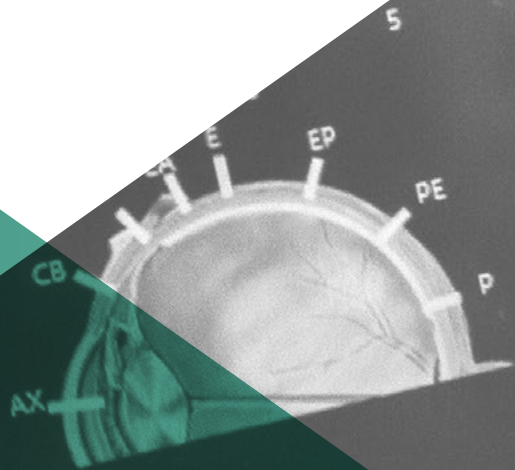

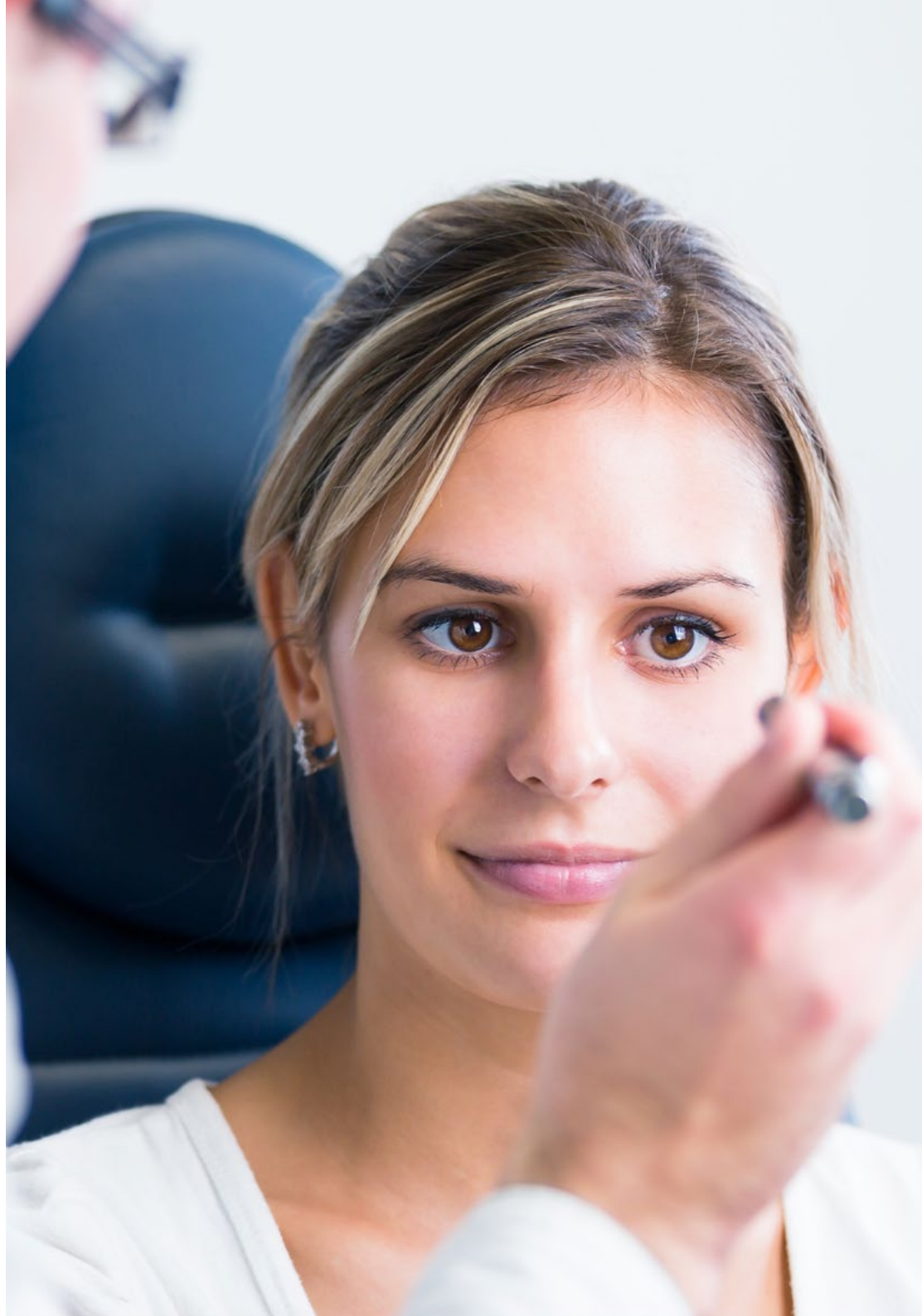

Methodology
