

# tech 06 | Introduction

Although there is no clear consensus on what constitutes research quality, there is agreement on some of the requirements that a research study must meet to be considered quality work.

Traditionally, quantitative methodology must meet criteria such as validity, generalizability, reliability and replicability. From other designs with qualitative and mixed methodologies, other criteria have been proposed, such as credibility or contribution to science or social change.

As important as it is to always try to promote studies of the highest possible quality, it is equally important to analyze and assess the quality of the scientific documents that reach the researcher, with the ultimate goal of being able to recognize that relevant unspecialized and with the best degree of scientific evidence, applicable to daily practice or to communicate to the scientific community.




# tech 22 | Methodology

#### At TECH Nursing School we use the Case Method

In a given situation, what should a professional do? According to Dr. Gérvas, the clinical case is the annotated presentation of a patient, or group of patients, which becomes a "case", an example or model that illustrates some peculiar clinical component, either because of its teaching power or because of its uniqueness or rarity. It is essential that the case is based on current professional life, in an attempt to recreate the real conditions in professional nursing practice.



Did you know that this method was developed in 1912, at Harvard, for law students? The case method consisted of presenting students with real-life, complex situations for them to make decisions and justify their decisions on how to solve them. In 1924, Harvard adopted it as a standard teaching method"

#### The effectiveness of the method is justified by four fundamental achievements:

- Nurses who follow this method not only grasp concepts, but also develop their mental capacity, by evaluating real situations and applying their knowledge.
- 2. The learning process has a clear focus on practical skills that allow the nursing professional to better integrate knowledge acquisition into the hospital setting or primary care.
- 3. Ideas and concepts are understood more efficiently, given that the example situations are based on real-life.
