General Objectives

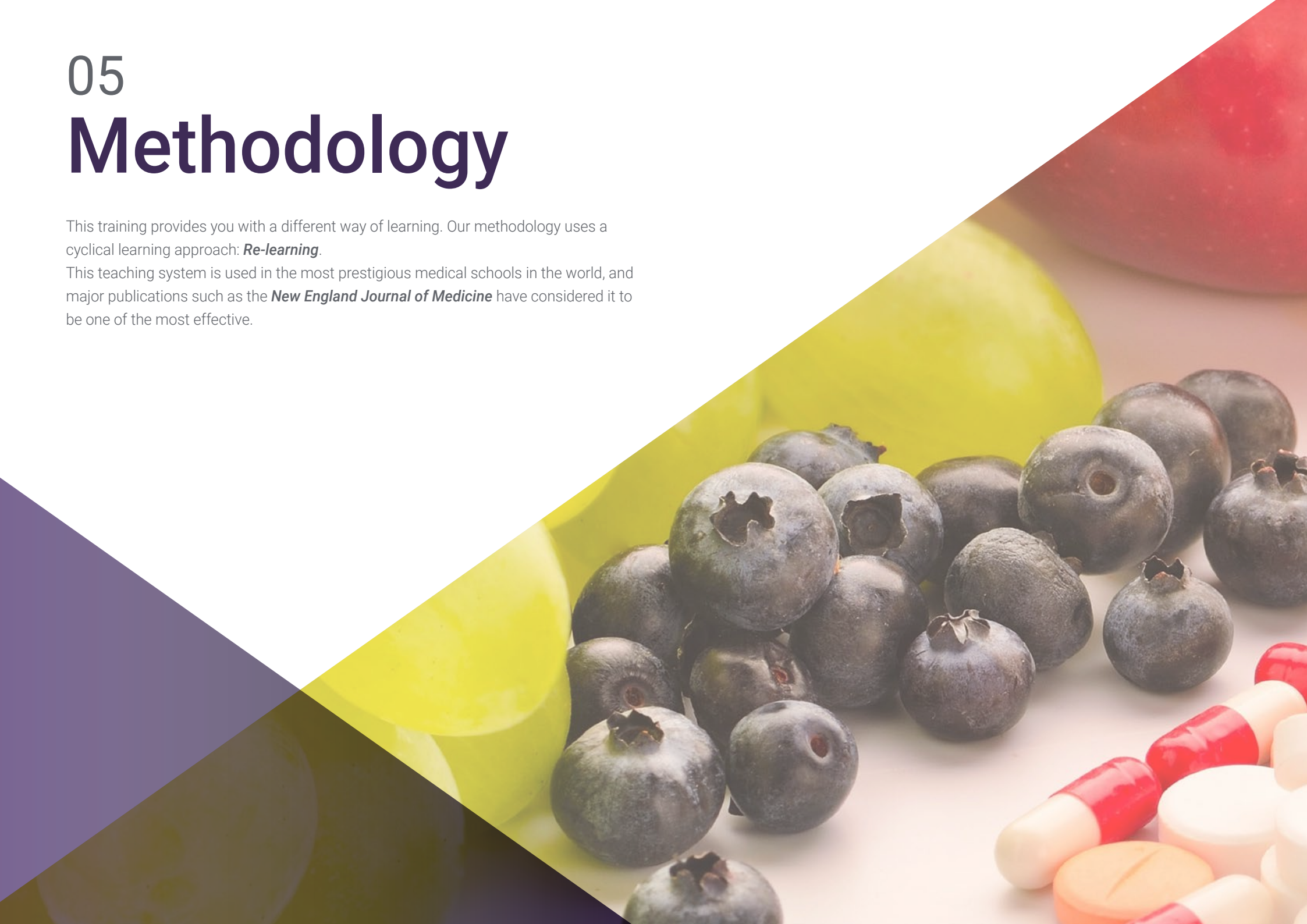

Methodology
