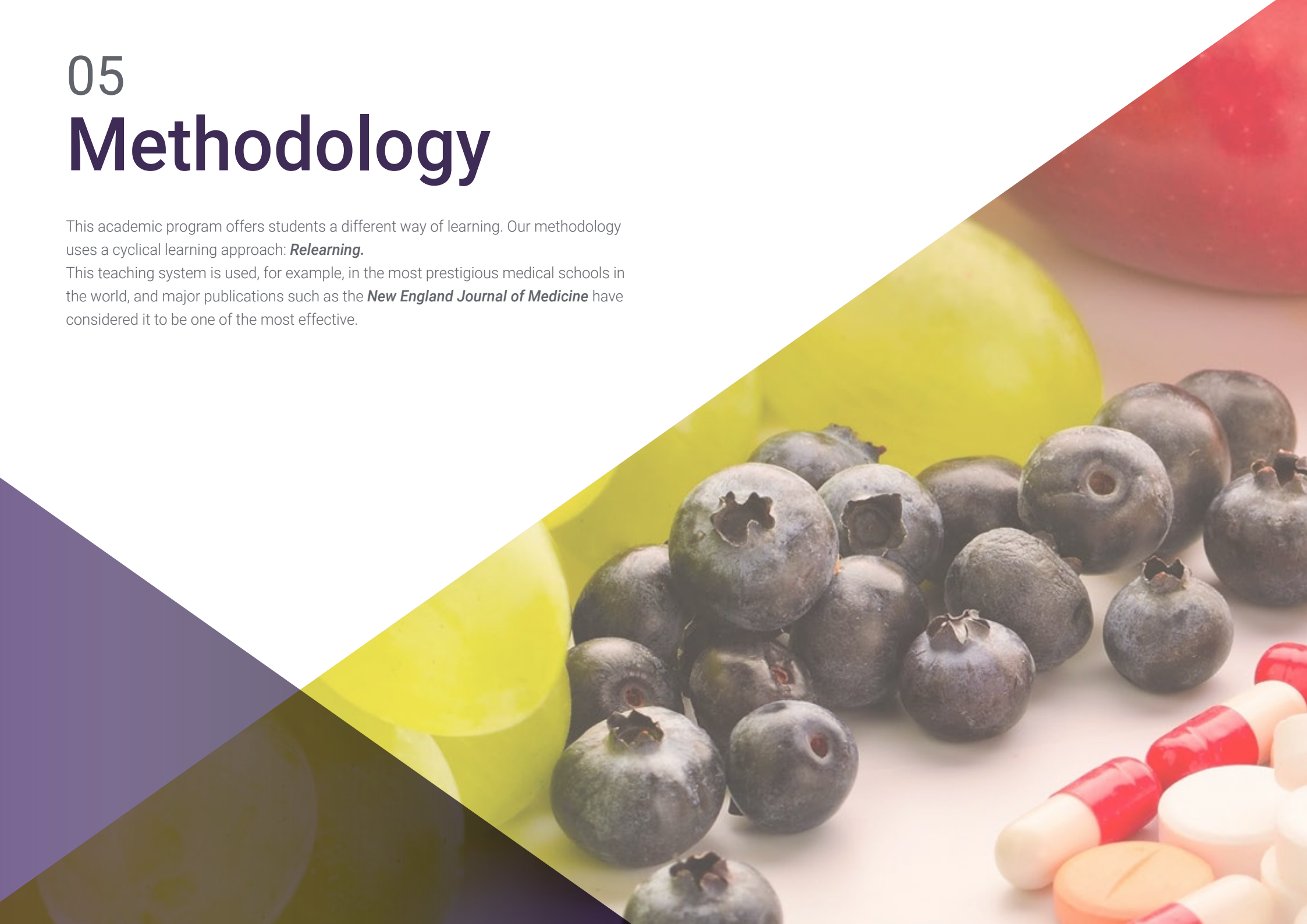

05 Methodology

In a given situation, what should a professional do? In 1924, Harvard adopted it as a standard teaching method”

The effectiveness of the method is justified by four fundamental achievements:

2. Learning is solidly translated into practical skills that allow the nutritionist to better integrate knowledge into clinical practice.

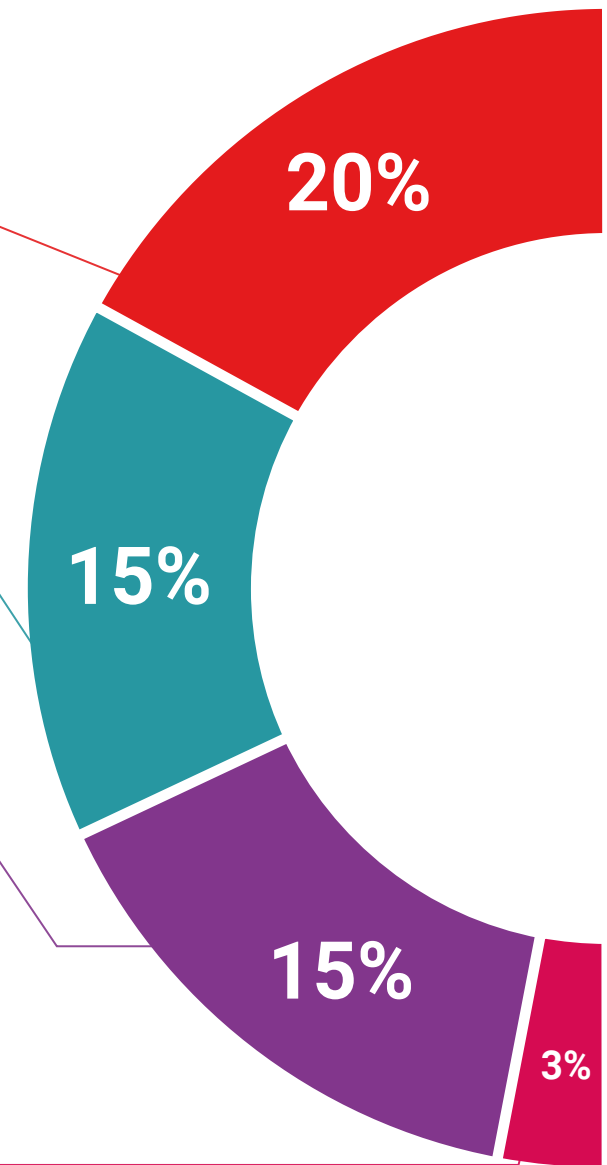
