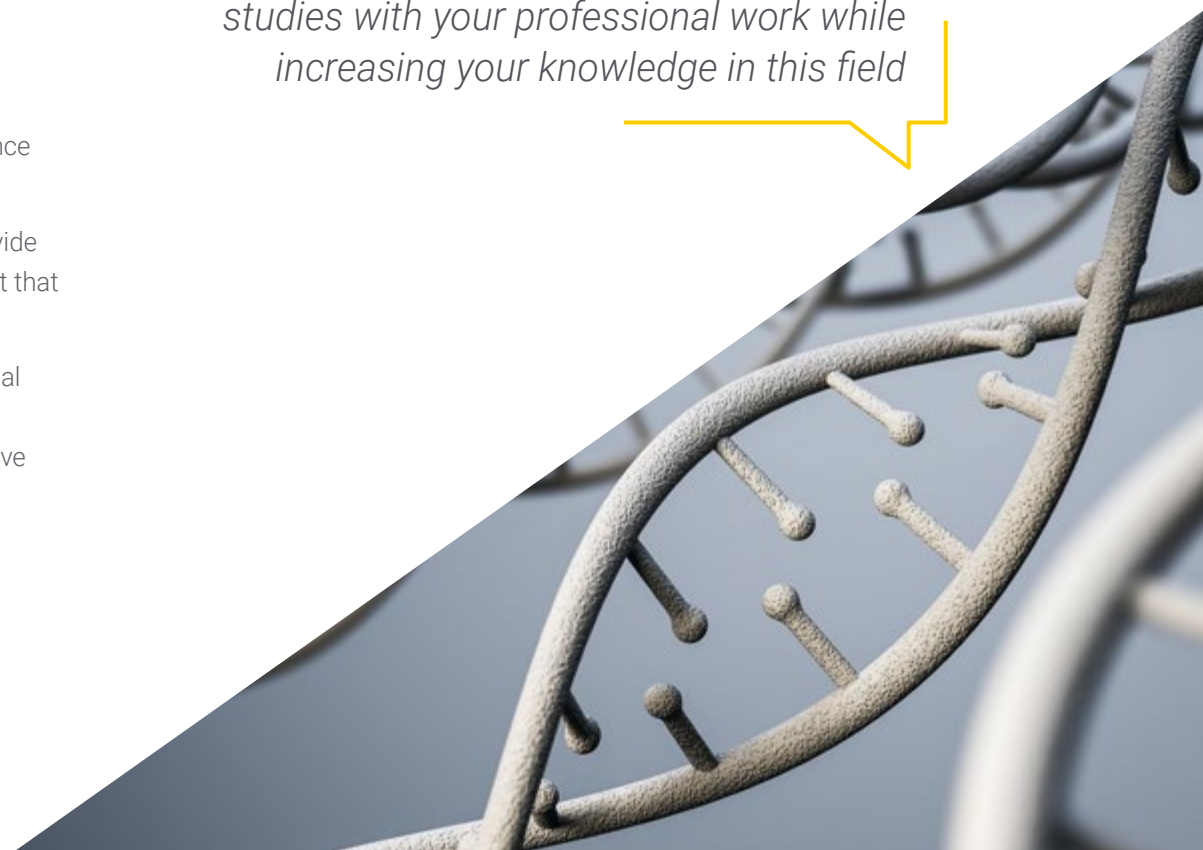

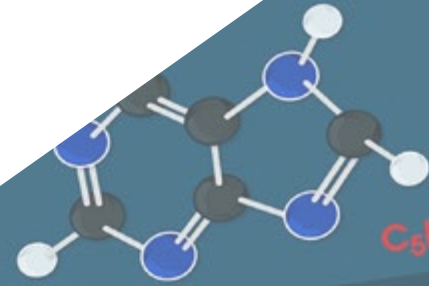

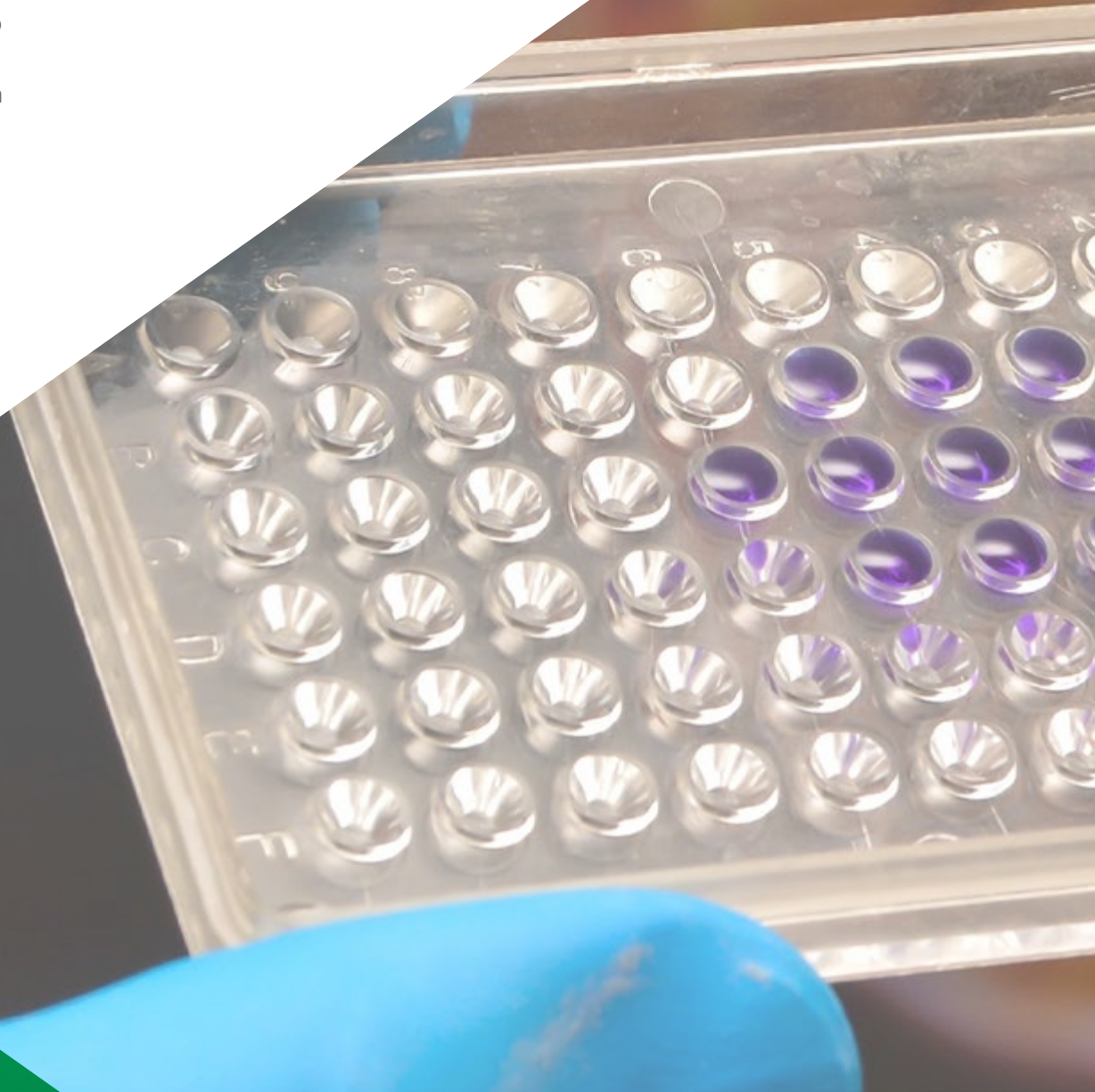

Methodology
