# 01

# Introduction

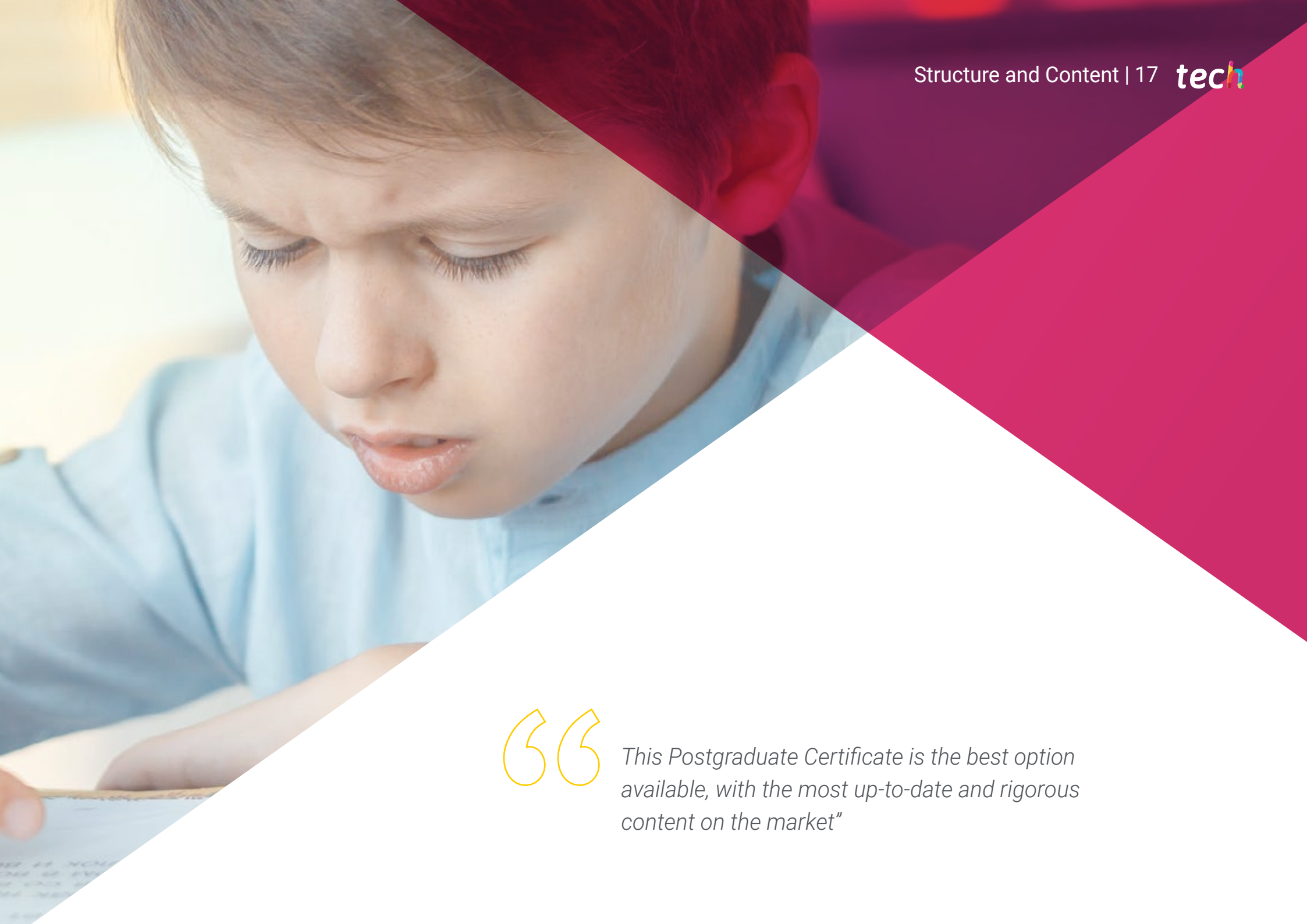

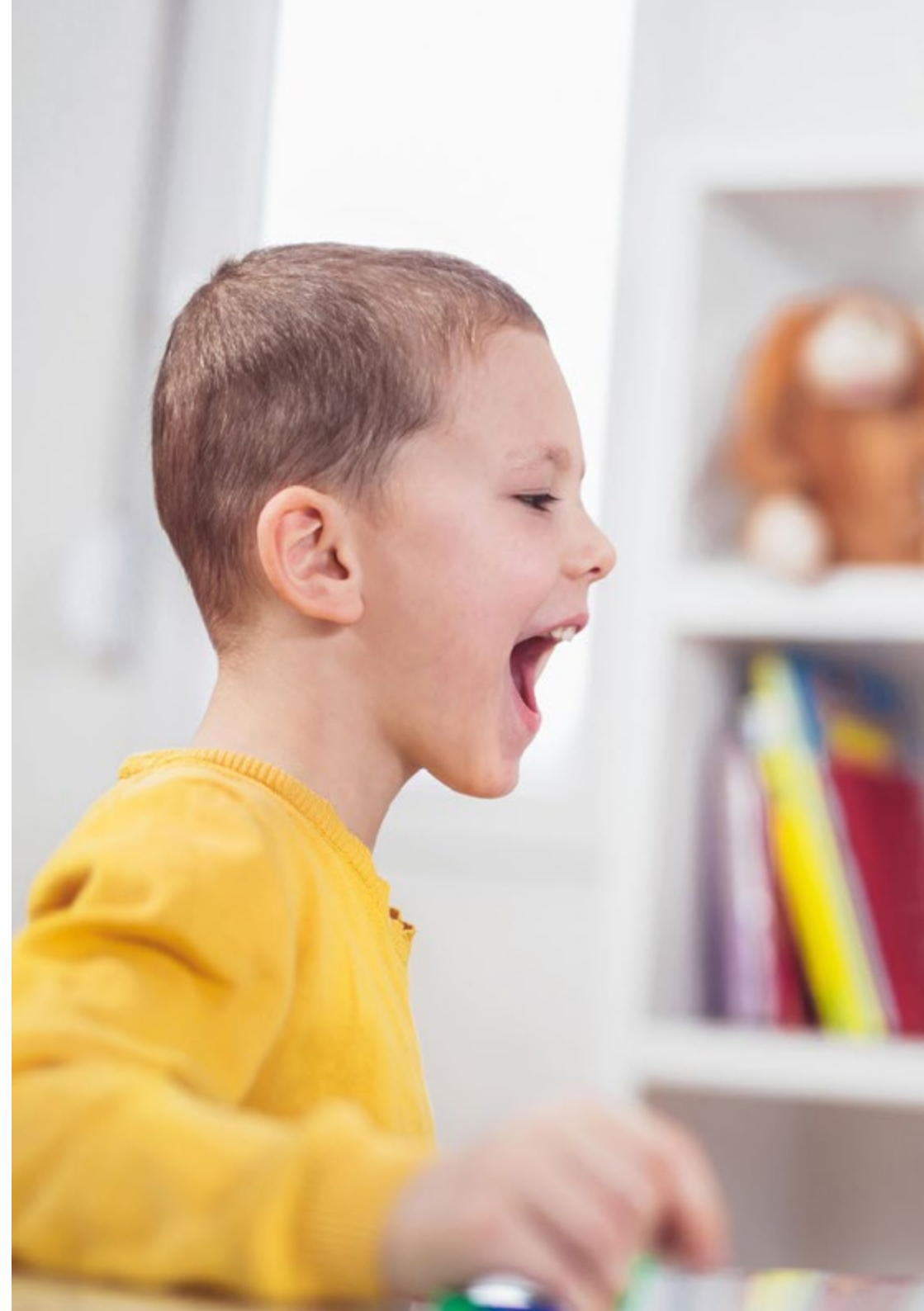

# Methodology
