Introduction

Medicines are drugs that are used for therapeutic purposes, alone or in combination, representing a specialty. The action of drugs in the body, as well as their origin, synthesis, preparation, properties, actions from the molecular level to the level of the whole organism, their way of positioning and moving in the body, forms of administration, therapeutic indications, toxic actions, all form Pharmacology knowledge.
