## **Geographical Distribution**





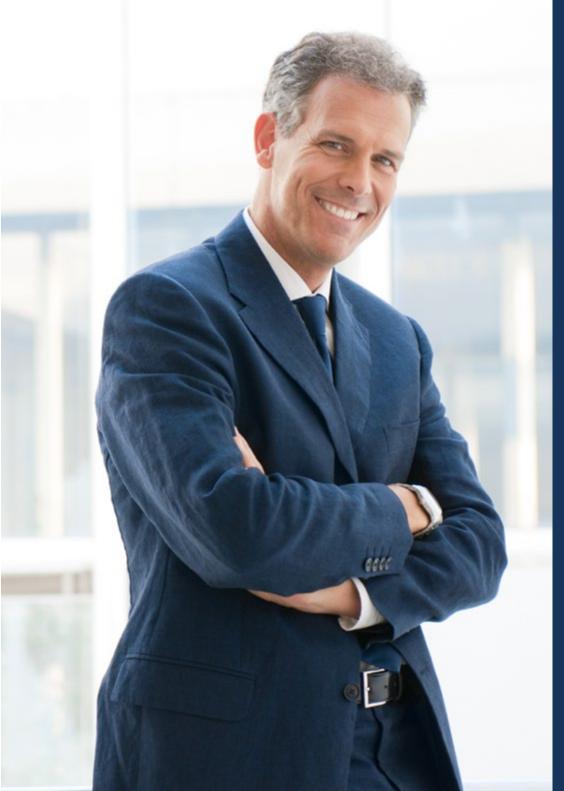
